These vulnerable citizens are living with serious and persistent mental illness, and TR provides them with behavioral health treatment and supportive housing services to ensure these folks remain safe, healthy, and housed. I served on TR's board for 15 years and can testify to its success at building community and stability for individuals who previously did not enjoy these things. TR owns or rents several properties and serves a multitude of people who live in various parts of West Seattle, but the majority of people it serves have their homes within very close proximity to TR's offices that are located on SW Avalon Way. Many of the people that TR serves will be irrevocably negatively impacted by the proposed alternative routes outlined in DEL-5 and DEL-6 if these options move forward. DEL-6 would be particularly devastating for them, but DEL-5 would also cause disruption and uprooting of people for whom such experiences are particularly difficult.
