WSLE Final EIS drop-in events

The project team hosted **two in-person drop-in events** following the publication of the West Seattle Link Extension (WSLE) Final Environmental Impact Statement (EIS) on Sept. 20, 2024.

These events allowed community members to review project materials, ask questions, and engage directly with project staff in advance of the Board's selection of final route and station locations.



Resources included maps, fact sheets, copies of the Final EIS, and visuals highlighting key elements of the Final EIS, as well as updates on the project timeline and next steps. Staff also shared how public, agency, and Tribal feedback was incorporated into the Final EIS and the broader decision-making process.

- The first drop-in event was at the Alki Masonic Center in West Seattle on Oct. 1, 2024. Onsite interpretation services were provided in Spanish and Vietnamese. About **69** people attended.
- The second drop-in event was at Gallery B612 in SODO on Oct. 2, 2024. About 14 people attended.



Community briefings and property owner meetings

The project team attended **22** community briefings and property owner meetings. Briefings included presentations and discussions with community groups such as the West Seattle Junction Association, Avalon neighbors, and SODO BIA, to share general project updates and answer questions. Property owner and tenant meetings included one-on-one conversations with owners, residents, and businesses to discuss the property acquisition and relocation process and answer questions.



Email updates

During the reporting period, the project team distributed an email update to a public listserv with over **12,000** subscribers. The update announced the Sound Transit Board's selection of the final alignment for the WSLE, highlighting key route and station decisions, project benefits, and next steps, including final design and anticipated construction in 2027.





Questions and feedback summary

- Timeline and status of property acquisition and relocation.
- Acquisition and relocation process for businesses.
- Hardship acquisition process.
- Follow-up on letters sent to potentially affected property owners.
- Requests for briefings for residents and businesses.
- Guideway distance from properties.
- Impacts to specific locations such as the West Seattle Health Club and Jefferson Square.
