2025 System Expansion Committee Work Program

In 2025, the System Expansion Committee will focus on three areas: 1) transactional matters to advance the capital system expansion programs that are in construction or approved for project development, 2) capital program review, and 3) topics of special interest to the committee.

Matters to advance the capital system expansion, for committee approval or referral to the Board

This work includes committee actions required for continued progress on the work of Sound Transit's system expansion capital program for working within the current project phase. As in previous years, items will include committee consideration and votes to approve or recommend actions to the Board, including:

- Contracts and contract modifications
- Interlocal and other agreements
- Project alternatives, budgets, and milestones
- Property acquisitions
- Regular project briefings to keep the committee informed and prepared for upcoming action items
- Other actions as needed for the capital expansion program

Sound Transit staff have compiled a projected list of specific actions they anticipate bringing before the committee for action by quarter, which is attached.

Capital Program Review

The System Expansion Committee will receive ad-hoc cost savings reports, biannual reports on the status of current and anticipated cost drivers, and will receive information on scope, schedule or budget challenges that are anticipated or may arise during the year, especially with regard to major components of the capital program or those that will require Board action.

In 2025, the System Expansion Committee will consider projects to be built, preferred alternatives, and/or EIS alternatives for the following projects:

- Graham Street Infill Station project
- South Boeing Access Road Infill Station project
- Tacoma Dome Link Extension project
- Ballard Link Extension project
- Sounder South Potential Additional Trips

In 2025, the Committee will also consider baseline budgets and/or budget amendments for the following projects:

- Amend Hilltop Tacoma Link Extension baseline budget
- Amend West Seattle Link Extension budget and project allocation to date to support final design
- Amend Tacoma Dome Link Extension budget and project allocation to date to support FEIS, design and delivery methodology
- Amend Bus Base North budget and project allocation to date to support construction
- Amend Everett Link Extension budget and project allocation to date to support project development

Topics of Special Interest to the Committee

The System Expansion Committee will also explore additional areas that are topics of interest to members, responsive to changing circumstances or the public, or emerging issues.

- Update on Long Range System Planning
- Project Management Information System (PMIS) implementation
- Discussion on proposed Key Performance Indicators (KPIs) for the Capital Program
- Presentation on the At-Grade Crossing 5-year master plan (*In conjunction with Rider Experience & Operations Committee*)
- Program and project cost work plan updates (per Resolution No. R2024-22 and Motion No. M2024-59), including presentation on standardized station designs and West Seattle Link Extension
- Presentation on designing for safety
- Presentation on designing for state of good repair and resiliency
- Other Topics suggested by System Expansion Committee members

The System Expansion Committee will receive quarterly reports on the capital program and project KPIs and will continue to receive updates as the program and projects advance and reach key milestones. KPIs will present metrics on performance across numerous areas of the program to include quality, cost and schedule that are gathered and tracked through the Project Management Information System.
