Executive Session

Chair Somers advised that the Committee was going into executive session to discuss the qualifications of CEO applicants. He introduced Amy Pearsall, Deputy General Counsel, who explained that the committee was allowed to enter into executive session to discuss the qualifications of applicants for public employment under RCW 42.30.110 (1)(g).

Chair Somers noted that the Committee would be in executive session for 20 minutes.

The executive session began at 4:12 p.m., with the Committee scheduled to return at 4:32 p.m.

The executive session was extended by 20 minutes, with the Committee scheduled to return at 4:52 p.m.

The executive session was further extended by 5 minutes, with the Committee scheduled to return at 4:57 p.m.

The Executive session was further extended by 2 minutes, with the Committee scheduled to return at 4:59 p.m.

The meeting was called back to order at 4:59 p.m.

Chair Somers opened discussion for the recommendation of a final CEO candidate to the Board of Directors.

Chair Somers expressed his thanks for all those involved in the CEO selection process. He noted the extensive amount of work undertaken over the last few months, as well as the large number of candidates that shared their interest in the position. Chair Somers further shared his perspective on the needed leadership qualities in a new candidate, including the ability to navigate difficult headwinds the agency faces.

Committee Vice Chair Balducci requested an overview of the process thus far. Gregg Moser, of Krauthammer and Associates, provided a brief outline of the CEO search process. He noted that the position was opened in late December following stakeholder discussions and feedback, which led to over 60 candidates of interest. From that, 15 candidates were found to meet the minimum qualifications for the position, who were then forwarded to the CEO Selection Team for continued review, resulting in the final pool of five candidates for interview, which was then narrowed to three finalists.

Committee Vice Chair Mello shared his experience and involvement in the process and thanked the Board for its work. He also noted that the finalists had the opportunity to meet with multiple groups for further screening. Vice Chair Mello also outlined his top desired qualities in a candidate, including the ability to serve the entire region, an understanding of the complexities of the region, and the ability to resolve tough challenges.

Board member Backus shared her thoughts on the process, expressing her thanks for the robust process and the opportunity to participate. She also shared her priority in a new CEO being able to complete and successfully deliver the program and build the "spine" of the light rail network from Everett to Tacoma.

Board member George noted that variety and diversity of the voices included in the CEO search process, highlighting his view that all parties have had the opportunity to be heard throughout the process.

Board member Franklin expressed her thanks for Chair Somers' leadership throughout the process, while noting the importance of selecting a CEO candidate who will prioritize the efficient completion of the "spine" light rail connection across the region.

It was moved by Committee Vice Chair Balducci and seconded by Board member Franklin that Candidate C be recommended to the Board for the Chief Executive Officer position and the Executive Committee Chair and Vice Chairs be authorized to negotiate an employment agreement with Candidate C with a goal of presenting an employment agreement to the Board for consideration.

Chair Somers called for a roll call vote.
