## Funding Agreement with King County Metro Transit for the Renton Transit Center

## **Proposed action**

Authorizes the chief executive officer to execute a funding agreement with King County Metro Transit (Metro) for Metro to reimburse \$50,000,000 to Sound Transit in support of delivering the Renton Transit Center as part of the I-405 Stride Bus Rapid Transit project.

# **Key features summary**

- The Sound Transit 3 System Plan (ST3) includes investments in bus rapid transit, which has since become known as Stride, including a station pair in south Renton as well as a transit center and bus layover.
- In May 2018 following Capital Committee approval of Motion No. M2018-31 in March 2018 –
  Sound Transit and King County Metro Transit (Metro) executed the System Expansion Transit
  Integration Agreement, which forms the basis for agency coordination for implementing ST3 projects
  and anticipates cost sharing from Metro for transit integration facilities.
- Since the adoption of ST3, Sound Transit and Metro have worked collaboratively on a robust
  planning and design process at the Renton Transit Center with the understanding that the design of
  the new facility will be based, in part, on relocating Metro services and functions that currently occur
  in downtown Renton and the South Renton Park and Ride.
- Metro's \$50 million commitment is based on Metro's proportional operational use of the Renton Transit Center, inclusive of the active bus bays, layover spaces, zero emissions infrastructure, and ancillary support facilities. This contribution amount was established at the 60% design milestone and has been reviewed and validated at subsequent design milestones.
- The funding agreement includes language for the potential of increasing Metro's contribution if actual costs require additional funding or to reduce scope if additional funding is unavailable.
- Metro's \$50 million reimbursement is included in the 2025 budget proposed by the King County Executive and that was adopted by the King County Council in November 2024.

#### Fiscal information

The proposed action would authorize a funding agreement with King County Metro to reimburse Sound Transit for the cost of design and construction services for Metro's proportional operational use of the Renton Transit Center, inclusive of the active bus bays, layover spaces, zero emissions infrastructure, and ancillary support facilities for a total authorized agreement not to exceed \$50,000,000.

Since the costs will be reimbursed to Sound Transit, this action does not impact the affordability of the agency's Long Range Financial Plan. If the total proportional cost based on Metro's proportional operational use of the Renton Transit Center exceeds the estimated reimbursement amount, the agreement allows for the reimbursement amount to be increased and amended by a future action.

While a one-month delay would not create a significant impact to the project schedule, both parties prefer to execute the funding agreement before Sound Transit begins procurement of the construction contract for Renton Transit Center.
