## **Executive Director Report**

Executive Director White reported that Puget Sound Transit Consultants has been selected for the contract for civil facilities design and preliminary engineering for Sound Transit's Link light rail system. The team consists of the engineering firms of Parsons, Brinkerhoff, Quade and Douglas; ICF Kaiser; and BRW as well as 35 subcontractors, 30 of which are Washington state firms.

## Motion No. 48 - Authorizing the Executive Director to execute contracts for bond counsel services

Mr. Nickels indicated he had asked staff to delay action on Motion No. 48 until the November 21 Executive Committee meeting (copy on file). Staff went through the selection process for bond counsel and is recommending that the Preston Gates & Ellis and Foster Pepper & Shefelman law firms serve as joint bond counsel to the RTA. However, staff still needs to define how the team will work together and get assurances that the team approach won't result in higher costs to the RTA.

## **Regional Fare Integration Activities**

Ms. Govern reported on the regional fare integration meeting that was held in the end of October. All of the transit agencies were represented and seven elected officials were in attendance, including four Executive Committee members. Ms. Govern indicated that the following "key messages" came out of the meeting:

- Let's do a better job than we are now
- We need to move quickly something should be in place by the third quarter of 1998
- Focus on benefits to the customer before internal operations
- Need to commit to a process
- Fare integration is only the first step, with service integration the goal

Next steps for regional fare integration activities are: 1) regional fare policy forum in December, where a few options will be selected for further review; 2) meeting in January to narrow the choices; and 3) 3<sup>rd</sup> meeting to achieve consensus, with the goal of adoption of regional strategy by the 3<sup>rd</sup> quarter of 1998.
