#### Action:

Authorizing the Executive Director to enter into an agreement with J & H Marsh McLennan to provide comprehensive Property & Casualty insurance broker services.

### **Background:**

The RTA published requests for proposals for the provision of insurance brokerage services. It was the RTA's intent to award one or more contracts in the following five categories: 1) Property and Casualty (comprehensive brokerage services); 2) General Liability; 3) Property (comprehensive brokerage of all real property and equipment coverages, including course of construction); 4) Premises and Operations for Administrative Services (brokerage of coverages for the business offices, contents, and activities of administrative staff-excluding EDP); and 5) Surety. Six companies responded with a total of twelve (12) separate proposals in three of the five category options published. This contract award is for comprehensive Property and Casualty brokerage services. J & H Marsh McLennan was selected because their proposal was the clear leader in responsiveness, quality and cost.

Separate agreements falling within the Executive Director's signature authority, pursuant to Resolution No. 78, are being awarded to Charles R. Horn Insurance, a certified MBE, to provide Premises and Operations-Administrative Services. In addition, the Selection Committee recommended that the joint proposal from J & H Marsh McLennan/C.R. Horn be accepted for negotiation to provide initial advisory services regarding Surety.
