### Citizen Oversight Panel 1997 Evaluation – Steve Goldblatt and Reid Shockey

Mr. Goldblatt began the Citizens' Year-End 1997 Performance Report on the RTA (copy on file.) He stated that the panel had sought the views of the public, of interest groups and of local agencies in order to gather information for the report. Panel members have attended Board meetings, community meetings, civic and professional meetings. They also conducted telephone and in-person interviews as part of their individual research. He went on to report that members had found a high level of interest among the entities and encouraged staff to redouble their efforts to spread the Sound Transit message and to make sure that the message gets down to the citizen level. He encouraged staff and the Board to also become strong advocates of the message.

Mr. Reid Shockey finished the report stating that the success of Sound Transit depends on integration with the other agencies. He also emphasized the need to work with local governments on transit oriented development and to resolve the issue of combining the light rail with the eastside transit tunnel.
