BACKGROUND:

Based on the locally preferred alignment identified in Motion M99-14 in February 1999, Link divided the architectural work into seven station design packages. This provided the opportunity for more firms to participate in this work..

On March 11, 1999, Sound Transit requested Statements of Qualifications from firms interested in consultant architectural, landscaping and urban design services for Preliminary Engineering and Final Design for the Central Link light rail system. Proposals were received on April 8, 1999. The Sound Transit Selection Committee evaluated and interviewed the final candidates and selected firms based on their proposals, staffing and level of effort.

Contract negotiations since that time have resulted in the summary of contract costs as listed above. These design services include design of the station finishes, preparation of plans, specifications and estimates for station architecture, including implementation of system-wide LRT signage requirements; station lighting fixture selection; station landscaping; and urban design of relevant streetscapes. Station Design Package #7 (South 154th Street – North SeaTac Station; SeaTac Airport Station; and South 200th Street – South SeaTac Station) is on a different time line that has to fit within the planning work currently being performed by the Port of Seattle. Therefore, no Board action is being requested on Package #7 at this time.

Of the firms selected for these six station design packages, a total of 28 firms are local companies within the Sound Transit service region and one is from outside the regional area. A summary of each team showing prime and sub-consultants address and percentage of project amount are attached to this background and comments document.

RELEVANT BOARD POLICIES AND PREVIOUS ACTIONS TAKEN:

- ♦ Adoption of Sound Move, The Ten-Year Regional Transit System Plan (May 31, 1996) Sound Move calls for coordinating with other transportation providers and creating important regional connections.
- Adoption of First Moves (May 22, 1997) Authorization for funding projects referred to as "First Moves" authorizes the executive director to begin in the development of interlocal agreements, and to develop cost sharing arrangements and agreements.
- ♦ Resolution No. 78-1, establishing delegation of authority and procurement procedures (April 9, 1998) Resolution No. 78-1 grants the Finance Committee authority to execute contracts up to \$5,000,000, and allows the Board to authorize nonstandard procurements, such as sole source and special circumstance procurements.
- ♦ Resolution No. 98-49, adopting Fiscal Year 1999 Budget (November 12, 1998)
 The 1999 budget includes funds for final design activities and the acquisition of rights of way.
- Resolution No. 98-3, awarding Civil Facilities Contract for Conceptual and Preliminary Engineering (January 22, 1998) Resolution No. 98-3 grants the Board to award a civil facility consulting contract for conceptual and preliminary engineering to a joint venture partnership composed of Parsons Brinkerhoff Quade & Douglas, Inc., ICF Kaiser Engineers, Inc., and BRW, Inc., dba Puget Sound Transit Consultants (PSTC).

♦ Motion No. M99-14, identifying the Central Link Light Rail Locally Preferred Alignment (February 25, 1999) Identifies the Central Link Light Rail LPA by segment, operations and Maintenance Facility, and Board Additions in 1995 dollars and 1999 dollars.

KEY FEATURES:

- Procurement of architectural services for preliminary engineering for Central link light rail with the ability to retain those architectural teams for final design.
- Allows for consistency in the design process and coordination with the local community and cities.

FUNDING:

Funding for this Scope of Work is included in *Sound Move* Plan and in the Link project budget, FTA Preliminary Engineering Grant, and FY'99 Capital Budget. The budget for completion of these tasks is identified in Sound Transit's 1999 Budget (page 86) under Preliminary Engineering, Final Design and Construction. With the current LPA configuration there is sufficient funding in the 1999 budget to complete the remaining work.

EXECUTIVE SUMMARY:

Scope of Work

Architectural design services include design of the station finishes, preparation of plans, specifications and estimates for station architecture. The scope of work also includes the following:

- community outreach in coordination with Sound Transit
- collaboration with Link artists
- interface with civil facilities and systems
- design of canopy structures
- implementation of system-wide LRT signage requirements
- station lighting fixture selection
- station landscaping

- urban design of relevant streetscapes
- identifying applicable permits

Procurement and selection process

All architecture teams have been selected through a competitive qualification-based process established in our Request for Qualifications and Proposals (RFQ/P) No. RTA/LR 32-99. Sound Transit staff fulfilled a good faith effort to fully disclose all available design materials and schedules developed by the Civil Facilities Design Consultant Team as part of the procurement process.

ALTERNATIVES:

The architectural design teams procured through this process will continue to support and provide design work to the ongoing civil engineering effort within the schedule allotted for preliminary engineering.

One alternative would be to not proceed with the architectural services until the final design phase of civil engineering. However, this alternative does not allow for design input from the architectural teams to the preliminary engineering effort of the civil facilities consultant. This alternative may also affect the final design schedule negatively in order for architectural design to be completed.

CONSEQUENCES OF DELAY:

If the award of this contract is delayed by more than six weeks, it will delay completion of the preliminary engineering work for these design segments, which will also delay the final design work. The award of contracts for architectural design is critical to the completion of the preliminary engineering and Station Design.

LEGAL REVIEW:

The Background and Comments and the Motion are approved as to legal sufficiency.

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority to award six separate contracts for professional services for architecture, landscaping and urban design services for the Central Link light rail.

Background:

Sound Transit has selected architectural consultant teams to provide professional services for the design of stations and associated urban design improvements for the Central Link Light Rail. These contracts will be awarded for both phases, however, only Preliminary Engineering will be authorized initially. The Central Link Light Rail alignment has been divided into seven station design packages for architectural procurements. Station Design Package #7 is on a different time line that has to fit within the planning work currently being performed by the Port of Seattle, therefore no contract amount is shown for that station design package.

Motion:

It is hereby moved by the Finance Committee of the Central Puget Sound Regional Transit Authority that professional services for architecture, landscaping and urban design services for the Central Link Light Rail project as outlined in RFQ/P No. RTA/LR 32-99 be provided through six separate contracts to the following firms:

Zimmer Gunsul Frasca Package #1
Arai Jackson Architects and Planners Package #2 and #5
Streeter Associates Architects. Package #3
Otak Package #4 and #6

These contracts include preliminary engineering and final design work. Initially only preliminary engineering will be authorized through a Notice to Proceed. Notices to Proceed for final design services will be issued following FTA's Record of Decision authorizing the Central Link light rail project to proceed with final design.
