## PROPOSED ACTION:

Approval of Motion No. M2001-14 would authorize the Executive Director to amend the existing contract with JD Edwards for software upgrade consulting services to upgrade existing financial and project management software for \$220,075 for a total amount not to exceed \$2,806,447.

## **KEY FEATURES:**

## Highlights of Proposed Action:

- Authorizes the Executive Director to amend the existing contract with JD Edwards for consulting services to upgrade existing financial and project management software for \$220,075 for a total amount not to exceed \$2,806,447.
- Scope includes: (1) implementation of software upgrade from a technical and functionality standpoint (2) mentoring and training on efficient ways of using upgraded software, and (3) knowledge transfer on best practices.
- Software Upgrade provides change management system and reporting tree functionality that JD Edwards was unable to provide in previous software versions.


## **Discussion of Proposed Action:**

In June 1999, Motion No. M99-22 approved a contract with JD Edwards for enterprise software and support and Moss Adams for system implementation support. The project was segmented into following three phases:

Phase 1 - financial, project cost, procurement and budget (95% complete) Phase 2 – fixed assets (95% complete) Phase 3 – payroll and human resources (60% complete) Phase 1 and 2 are 95% complete with reporting and functionality enhancements remaining. Phase 3 is 60% complete with a 2nd quarter date of going live with paychecks. The table on the next page depicts the status of both of the above contracts through December 31, 2000:

Sound Transit has standardized a set of applications being used by project managers referred to as our "tool box" that includes the following applications: financial/project management (JD Edwards "One World), scheduling (Primavera P-3) and document management (Doc Link). The picture below details the project manager's "tool box" and the next step in our evolution is the integration of the "tool box." The integration of the "tool box" will be addressed through the review of the project control systems currently being planned per the Board briefing book dated January 11, 2001, and reported back on later.



This proposed action is authorizing the upgrade of our One World software that will benefit the agency in the following ways:

- Enhanced reporting capability.
- Automated change management functionality.
- Ability to have web based interface.
- Improved integration and access to industry standard tools.
- Improved reliability of source code.

In June 1999, Motion No. M99-22 approved a contract with JD Edwards for enterprise software and support and Moss Adams for system implementation support. The project was segmented into following three phases:
