MOTION NO. M2001-16

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the Acting Executive Director to execute Modification #2 to Amendment #1 of Contract RTA/LR 39-00 with CH2MHILL to add \$122,505 to extend Mr. Wilson's tenure as Interim Link Director to 120 days for a new total authorized amount not to exceed \$221,010.

Background:

In November 2000, Sound Transit executed Amendment #1 to an existing contract with CH2MHILL to add an additional scope of work. The terms of the amendment allowed for Mr. Wilson's services to be provided for a period of not less than 60 days nor a period greater than 120 days, at a cost not to exceed \$98,505. Amendment #1 constituted a sole source procurement because it added a new scope of work to the contract. The procurement, being less than \$100,000, was within the delegated signature authority of the Executive Director.

On January 29, 2001, Sound Transit executed Modification #1 to Amendment #1, to extend Mr. Wilson's tenure to 120 days (concluding no later than March 18, 2001) and increase the total cost not to exceed to \$100,000. The proposed action would authorize execution of Modification #2 to Amendment #1 to increase the total cost not to exceed to \$221,010 to provide for the extended tenure.

Mr. Wilson's scope of work over the next 60 days includes 1) implementing the six-month work plan; 2) project control realignment; 3) getting the Technical Advisory Committee in place and functioning; 4) addressing the need for community dialogue; 5) aligning staff and consultants within Link to a configuration that supports construction; 6) preparing and briefing the Board on the project's progress and milestones; 7) positioning the agency to consummate a tunnel construction contract; and 8) continuing to share discussions concerning potential changes to expectations concerning Link.

Mr. Wilson's scope of work over the next 60 days includes 1) implementing the 6-month work plan; 2) project control realignment; 3) getting the Technical Advisory Committee in place and functioning; 4) addressing the need for community dialogue; 5) aligning staff and consultants within Link to a configuration that supports construction; 6) preparing and briefing the Board on the project's progress and milestones; 7) positioning the agency to consummate a tunnel construction contract; and 8) continuing to share discussions concerning potential changes to expectations concerning Link.

It is hereby moved by the Board of the Central Puget Sound Regional Transit Authority to authorize the Acting Executive Director to execute Modification #2 to Amendment #1 of Contract RTA/LR 39-00 with CH2MHILL to add \$122,505 to extend Mr. Wilson's tenure as Interim Link Director to 120 days for a new total authorized amount not to exceed \$221,010.
