### **OBJECTIVE OF ACTION**

• Fund the remainder of the second year of the contract with Campbell Brothers Maintenance Corp. for Union Station, the Great Hall, and the Weller Street Bridge.

#### **ACTION**

 Authorizing the Executive Director to expend \$66,357 to fund the remaining term of the contract with Campbell Brothers Maintenance Corp., for a total authorized amount not to exceed \$283,357.

#### **KEY FEATURES**

- The Campbell Brothers Maintenance Corp. contract includes: Union Station and the Weller Street Bridge. The scope of the contract includes normal cleaning duties such as trash removal, restroom cleanliness, vacuuming, dusting, mopping, etc.
- The Campbell Brothers Maintenance Corp. contract expires on May 20, 2003. Finance Committee approval will allow Sound Transit to provide funds for janitorial services through May 20, 2003, prior to which another competitive procurement will be completed.
- This contract was competitively bid in May of 2001.

#### M/W/DBE - SMALL BUSINESS PARTICIPATION

The Union Station Janitorial Solicitation RTA/FA 23-01 published in April 2001 did not have a stated M/W/DBE goal. The solicitation encouraged the submittal of bids from firms certified as Minority, Women, and Disadvantaged Business Enterprises. Out of 10 bids received, Campbell Brothers Maintenance Corp. was the lowest successful bidder. Although not certified as an M/W/DBE firm, Campbell Brothers Maintenance Corp. represents themselves as a small business with a combined minority and female ownership of 51%.

#### **HISTORY OF PROJECT**

In March 2001, an Invitation for Bid (IFB) RTA/FA 23-01 was prepared for Union Station and the Weller Street Bridge including all work areas and the Great Hall. The IFB requested a firm fixed price, a monthly rate for a two year contract for "Regular Monthly Service", an hourly rate for additional work not anticipated in the scope of work and a price for Great Hall and ancillary areas work. In addition, the bid form requested optional bid prices for floor cleaning, carpet cleaning, hard floor stripping and waxing and window cleaning (interior and exterior). State Prevailing Wage is mandatory on this project. Ten firms bid on the Union Station janitorial project. Campbell Brothers Maintenance Corp. was the successful bidder.

A two year contract was awarded in May 2001 to Campbell Brothers Maintenance Corp. based on the approved budget amount for the first two years with an option for a third year. The two year contract has reached the \$200,000 threshold at which Finance Committee action is required.
