# **OBJECTIVE OF ACTION**

Procurement of server network equipment and workstations for the remainder of the 2003 budget year and for 2004 budget year.

#### **ACTION**

Authorizes the Chief Executive Officer to execute a contract with Dell Business Solutions to provide server network equipment and work stations for a total authorized amount not to exceed \$540,000.

# **KEY FEATURES**

- Authorize the Chief Executive Officer to execute a contract with Dell Business Solutions to provide server network equipment and workstations for a total authorized amount not to exceed \$540,000.
- Replaces aging server network equipment and workstations that are reaching the end of their useful lives.
- This contract is being procured through a piggy-back agreement on a State of Washington Department of Information Services Master Contract for Dell Business Solutions hardware. Using this master contract allows Sound Transit to take advantage of the 15% to 40% discount, without having to engage in a lengthy RFP process.
- Agency Information Technology staff performed a hardware review and chose Dell Business Solutions over IBM and HP/Compaq. Dell Business Solutions demonstrated superior hardware support and staff support at the least cost to the agency.
- Funding (\$250K) is included in the FY2003 Budget and additional budget (\$290K) has been requested in the Proposed 2004 Budget.

## **BUDGET IMPACT SUMMARY**

The amount requested is included in the Proposed 2004 budget, therefore no action outside of the Board-adopted budget will be necessary. There are no contingency funds required, no subarea impacts, or funding required from other parties.

# **BUDGET DISCUSSION**

Funding for the portion of this scope of work anticipated to occur in 2003 (\$250K) is included in the FY2003 Budget and additional budget (\$290K) has been requested in the Proposed 2004 Budget.

Dell Business Solutions has provided Sound Transit with a copy of this statement, which is attached. The vendor will not be using subconsultants on this hardware procurement contract.

## **HISTORY OF PROJECT**

This procurement would replace aging server network and workstation equipment that is reaching the end of its useful lives. The agency has begun replacing network servers originally purposed in 1997. Workstations are replaced as needed, usually between three and four years. Proactive replacement reduces the chances of major component failure which could result in loss of the availability of part or all of the agency data network, including the agency web site, external e-mail, project controls, finance, and /or CAD applications, for an extended period of time.
