### **OBJECTIVE OF ACTION**

To receive programming support for the agency Enterprise Resource Planning (ERP) application through amendment of the existing contract with AMX International for OneWorld technical consulting services.

### **ACTION**

Authorizing the Executive Director to execute a contract amendment with AMX International Associates to continue to provide OneWorld technical consulting services in the amount of \$155,000 for a new total authorized contract amount not to exceed \$350,000 and exercising the option to extend the contract through December 31, 2004.

### **KEY FEATURES**

- Contract amendment continues necessary, highly-technical on-call programming and upgrade support for the JD Edwards OneWorld system
- Defines a scope of work, including:
  - technical support for the Configurable Network Computing (CNC) administration of OneWorld to manage the objects within the system.
  - troubleshooting support for report writing refinements
  - upgrade assistance for installation of major updates and service packs
  - configuration support for web client/server installation, and
  - general technical support for future OneWorld functionality expansion.
- Exercises the single one-year option on the contract as work is expected to continue into 2004.


### **REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS**
