Motion No. M2004-76 – Authorizing the Chief Executive Officer to execute a contract amendment with AMEC Earth & Environmental, Inc., to provide geotechnical engineering services during construction for the South Boeing Access Road to South 154th Street line section of the Central Link Light Rail Initial Segment in the amount of \$397,810 plus a contingency of \$4,781 for a total of \$402,591 and a new total authorized contract amount not to exceed \$2,281,170

Motion No. M2004-79 – Authorizing the Chief Executive Officer to execute an amendment to an existing sole source contract with Integrated Business Solutions to continue upgrading the Agency Forecasting Tool software in the amount \$89,000, for a new total authorized contract amount not to exceed \$188,000

Motion No. M2004-78 – Authorizing the Chief Executive Officer to execute a contract with Balfour Beatty, Inc. for construction of the Pine Street Stub Tunnel and retrofit of the Downtown Seattle Transit Tunnel in the amount \$82,700,000, with a 10% contingency of \$8,270,000, for a total authorized amount not to exceed \$90,970,000, which includes reimbursements to Sound Transit by King County Metro and Qwest for betterment work in the amount of \$8,126,871

Mr. Joe Gildner and Mr. Martin Schanenmayer, Link Light Rail Project Controls Program Manager, presented Motion No. M2004-78.

It was moved by Mr. Crawford, seconded by Mr. Olson, and carried by the unanimous vote of all members present that Motion No. M2004-78 be forwarded to the Board with a do-pass recommendation.

Motion No. M2004-77 – Authorizing the Chief Executive Officer to execute a contract with Parsons Brinckerhoff Construction Services, Inc. to provide construction management services for the South Boeing Access Road to South 154th Street line section of the Central Link Light Rail Initial Segment in the amount of \$11,136,363 with a 10% contingency of \$1,113,637, for a total authorized contract amount not to exceed \$12,250,000

Mr. Samer Tamimi, Link Light Rail Construction Manager, and Mr. Henry Cody, Link Light Rail Construction Engineer presented Motion No. M2004-77.

It was moved by Mr. Crawford, seconded by Mr. Olson, and carried by the unanimous vote of all members present that Motion No. M2004-77 be forwarded to the Board with a do-pass recommendation.
