OBJECTIVE OF ACTION

To provide for one new appointment to the Citizen Oversight Panel.

ACTION

Appointment of Mary McCumber from the Seattle/North King County subarea to the Citizen Oversight Panel for a term of four years, beginning May 2004 and expiring May 2008.

KEY FEATURES

This new appointment fulfills the active recruitment for the four vacancies resulting from two panel members whose terms expired and two panel members who resigned. The Sound Transit Board filled the three other vacancies at its April 8, 2004, meeting.
