## **OBJECTIVE OF ACTION**

Extend the current ST Express bus service interagency agreements through December 31, 2004.

## ACTION

Authorize the Chief Executive Officer to extend the existing interagency service agreements with Community Transit, King County Metro, and Pierce Transit through December 31, 2004.

## **KEY FEATURES**

The current interagency agreements for the operation and maintenance of ST Express bus service expire on September 25, 2004. This action would authorize the Chief Executive Officer to execute amendments to the current agreements extending them through December 31, 2004.

#### **BUDGET DISCUSSION**

The Adopted 2003 Service Implementation Plan, the Adopted 2004 Budget, and the Financial Plan have sufficient resources to cover the estimated purchased transportation costs from September 25, 2004, through December 31, 2004. The total estimated cost for the final three months of 2004 is \$12,018,000.

## REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is consistent with the Adopted 2004 Budget and is affordable within Sound Transit's current long-term Financial Plan and the financial capacity of the subareas. Each of

the subareas, South King, East King, Snohomish, and Pierce, will pay their subarea share for the costs of the Regional Express bus service.

The current interagency agreements with Community Transit, King County Metro, and Pierce Transit for the operation and maintenance of ST Express buses expire on September 25, 2004. In 2003, the Board directed staff to negotiate new service agreements with the existing transit agency partners. The proposed new agreements change the compensation methodology and reporting requirements. The parties need additional time to prepare for these changed responsibilities. It will also be less complicated in the future for the change to occur at the start of a new budget year. Staff is requesting that the current five-year agreements be extended from September 25, 2004, through December 31, 2004.

## **CONSEQUENCES OF DELAY**

The current Agreements expire on September 25, 2004, and without Board authorization to extend them through 2004, service cannot be operated.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the Chief Executive Officer to extend the Interagency Agreements with Community Transit, King County Metro, and Pierce Transit for Regional Express Bus Service Operations and Maintenance from September 25, 2004, through December 31, 2004.

# Background:

Regional Express buses are operated and maintained by Community Transit, King County Metro, and Pierce Transit under interagency agreements with Sound Transit executed in 1999. The agreements expire on September 25, 2004. As part of the transition process for the new five-year agreements, staff is requesting that the current agreements be extended through December 31, 2004. The new agreements change the compensation methodology and reporting requirements, and the parties need additional time to prepare for these changed responsibilities. It will also be less complicated in the future for the change to occur at the start of a new budget year. The Adopted 2003 Service Implementation Plan, the Adopted 2004 Budget, and the Financial Plan have sufficient resources to cover the estimated purchased transportation costs through the remainder of the year. The total estimated cost for the final three months of 2004 is \$12,018,000.
