### **ACTION**

Authorizes the Chief Executive Officer to execute a task order with the Washington State Department of Transportation under the existing Umbrella Agreement GCA 3361 covering construction administration of Sound Transit projects within Washington State Department of Transportation right-of-way for the Link Light Rail Tukwila Freeway Route construction, in the amount of \$572,100, with a 10% contingency of \$57,210, for a total authorized amount not to exceed \$629,310.

### **KEY FEATURES**

- The Washington State Department of Transportation's (WSDOT) oversight role is defined in a task order that covers the coordination of all issues affecting the Link Light Rail Tukwila Freeway Route project including environmental concerns, utilities, inspection, change order review and approval and closeout activities.
- Defines WSDOT's oversight role during the Tukwila Freeway Route construction the C755 civil contract South Boeing Access Road to South 154th Street and the C757 civil contract South Boeing Access Road to South 154th Street Utility Relocation.
- Authority for WSDOT's role comes from the existing Umbrella Agreement GCA 3361 that
  was executed on October 13, 2002, and covers construction administration of Sound Transit
  projects within WSDOT right of way.
- WSDOT will have dedicated inspectors on site for the duration of the construction work.
   These inspectors will coordinate with the Sound Transit construction management team and other WSDOT offices and departments.

### **BUDGET IMPACT SUMMARY**

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

# **BUDGET DISCUSSION**

The proposed action would authorize execution of a task order with the Washington State Department of Transportation (WSDOT) under the existing Umbrella Agreement GCA 3361 covering construction administration of Sound Transit projects within WSDOT right-of-way for the Link Light Rail Tukwila Freeway Route construction (C755 and C757), in the amount of \$572,100 plus a 10% contingency of \$57,210, for a total authorized amount not to exceed \$629,310.

The adopted 2005 lifetime capital budget for the Initial Segment is \$2.07 billion. This action is to approve a task order for \$629,310 using funds that are budgeted for the existing WSDOT agreement, under a \$1,200,000 budget line item in the third party phase of that budget. Within the WSDOT agreement, task orders totaling \$212,100 have been authorized by Sound Transit to date. The proposed action would increase that amount to \$841,420 and leave a remaining balance of \$358,580 in the WSDOT budget line.

# REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS

The proposed action is consistent with the current Board-adopted budget and is affordable within the agency's current long-term financial plan and subarea financial capacity. The action will have no new revenue impact on Sound Transit.

To date four construction task orders have been executed with WSDOT for the Central Link Light Rail Initial Segment. These task orders are for the E-3 pole relocation (C705), downtown tunnel retrofit (C510), the E-3 Busway (C700), and the Beacon Hill Tunnel (C710).

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the Chief Executive Officer to execute a task order with the Washington State Department of Transportation under the existing Umbrella Agreement GCA 3361 covering construction administration of Sound Transit projects within WSDOT right-of-way for the Link Light Rail Tukwila Freeway Route construction in the amount of \$572,100, with a 10% contingency of \$57,210, for a total authorized amount not to exceed \$629,310.

### Background:

A Memorandum of Understanding (MOU) executed on October 23, 1997, established a cooperative relationship between Sound Transit and the Washington State Department of Transportation (WSDOT). The MOU covered the regional express/HOV system, commuter rail, and light rail and established working principles between the agencies to facilitate the design, construction, and operation of capital projects listed in Sound Move; coordinated public transportation service provided by each agency; and provided for future agreements dealing with specific programs or projects related to Sound Move.

On May 13, 2002, the Sound Transit Board authorized the Executive Director to negotiate and execute an umbrella agreement with WSDOT for construction administration of Sound Transit projects to be constructed on WSDOT right-of-ways in accordance with key provisions, including Link light rail use of State right of way.

Sound Transit and WSDOT executed a construction umbrella agreement on October 13, 2002, related to the construction administration of Sound Transit projects to be built within WSDOT right of way.
