## **PROJECT NAME**

Kirkland Transit Center/3<sup>rd</sup> Street Project

# **PROPOSED ACTION**

Authorizes the Chief Executive Officer to execute a contract with INCA Engineers, Inc. to provide preliminary engineering and environmental documentation services with an option for final design support services for the Kirkland Transit Center/3<sup>rd</sup> Street Project in the amount of \$890,254, with a 10% contingency of \$89,025, for a total authorized contract amount not to exceed \$979,279.

## **KEY FEATURES of PROPOSED ACTION**

- This action defines a scope of work for preliminary engineering and environmental documentation of the Kirkland Transit Center/3<sup>rd</sup> Street Project.
- The contract includes an option for final design support services including creating final
  plans, specifications, and estimates as well as design assistance during construction.
   Separate Board review and approval would be required prior to commencing work on this
  optional contract scope.

## **BUDGET IMPACT SUMMARY**

Project Name: Kirkland Transit Center/3<sup>rd</sup> Street

Current Project Phase: PE/ED

Projected Completion Date: To be determined.

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET AND FINANCIAL PLAN DISCUSSION**

The 2006 Adopted Board Budget for this project is \$13,300,000, with a Board-adopted preliminary engineering phase budget of \$1,050,000. The proposed action would leave a remaining preliminary engineering phase budget of \$70,721 and a remaining uncommitted balance for the project budget of \$12,320,318.

There are sufficient funds to complete this action. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

The project's budget will be detailed further at the preliminary engineering phase level, as staff works with the City of Kirkland and other stakeholders to define a more detailed scope.
