# **ACTION**

Authorizes the Chief Executive Officer to execute a contract amendment with Perteet, Inc., to provide on-call transit planning services in 2006 and 2007, in the amount of \$186,000 for a total authorized contract amount of \$500,000.

## KEY FEATURES

- Provides continuity of transit planning through 2007 as Sound Transit implements the recommendations from the Comprehensive Operational Analysis (COA) of Sound Transit services.
- Allows staff to acquire additional professional resources as necessary during development of the annual Service Implementation Plan or for unanticipated needs related to transit operations and service planning.
- Staff would only use the consultant when specialized disciplines are needed or when additional resources are required to meet schedules for time-sensitive projects.

#### BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET DISCUSSION**

The Finance Committee approved Motion No. M2005-42 on April 21, 2005, authorizing a contract with Perteet, Inc., to provide a Comprehensive Operational Analysis of Sound Transit services for an amount of \$314,000. Resources for transit planning services are included in the current Long-Range Financial Plan. The amendment, if approved, would authorize the expenditure of up to \$186,000, for 2006 and 2007. While the original contract for the COA will

be funded in the 2005 transit operations budget, funding for the on-call services would be provided in the 2006 and 2007 transit operations budgets.

### **REVENUE, SUBAREA, AND FINANCIAL PLAN IMPACTS**

The proposed action is consistent with the current Board-adopted budget and is affordable within Sound Transit's current Long-Range Financial Plan and the subarea financial capacity. There are no additional revenues accruing to Sound Transit as a result of this action.

### BUDGET TABLE

This action will be funded in the 2006 and 2007 ST Express transit operations budget. It will be included in the Transit Planning and Financial Services budget section.

Motion No. M2005-42 as originally proposed by staff, authorized additional consultant work to be provided on an on-call basis during 2006 and 2007. The Finance Committee authorized the COA/SIP work and amended the motion to defer the on-call services, in order for staff to return later with more information on the benefits of the services.

The on-call services contract amendment would allow consultant assistance to be provided as needed for a variety of tasks. These tasks require specialized knowledge in transit operations, data collection, customer surveys, service evaluation and schedule analysis, among other disciplines. Examples of consultant work performed under previous on-call contracts include:

- Operational evaluation of long-haul transit buses in downtown Seattle. This evaluation concluded that long-haul transit buses could be operated in downtown Seattle without significantly impacting other service, leading to a decision to purchase 13 such buses for the Sound Transit fleet.
- Schedule efficiency analysis of Sound Transit's Seattle-Tacoma bus service. This analysis resulted in a new schedule that required two fewer buses and reduced operating costs by approximately \$150,000 per year.

- Customer travel surveys at overcapacity Sounder park and ride lots. Data obtained through these surveys will assist in developing strategies for addressing park and ride overcrowding.
- Route 545 Redmond-Seattle ridership analysis with Capitol Hill routing. This confirmed earlier staff work that quantified the ridership trade-offs between existing and proposed new routing.

At this point staff anticipates that the COA and the 2005 SIP work will require follow-up analysis to ensure that service is consistent with Sound Transit's planning standards and is implemented as efficiently as possible. The availability of on-call consultant assistance allows Sound Transit to maintain a relatively small service planning staff while being responsive to the constantly-changing needs of Sound Transit's customers.

# **CONSEQUENCES OF DELAY**

Early authorization of the contract amendment would allow the contract to be included in the Draft 2006 Budget. If action on the contract amendment is delayed, it may require later adjustment of the 2006 Budget.

#### Background:

Motion No. M2005-42 as originally proposed by staff authorized additional consultant work to be provided on an on-call basis during 2006 and 2007.
