PROJECT NAME

Issaquah Transit Center/SR900

PROPOSED ACTION

Authorizes the Chief Executive Officer to execute a partnership agreement with the City of Issaguah regarding development of the Issaguah Transit Center/SR900.

KEY FEATURES of PROPOSED ACTION

- Establishes an agreement between Sound Transit and the City of Issaquah on roles and responsibilities regarding the development of the Issaquah Transit Center/SR900 project.
- The agreement covers design, right of way acquisition, permitting, construction, and security/surveillance for the facility.
- The proposed action authorizes the Chief Executive Officer to dispose of approximately onehalf acre of property (along with related easements and easements required by development regulations) through a transfer to the City of Issaquah for future development of an Eastside Fire & Rescue Station No. 72 as provided in the agreement.
- City of Issaquah agrees to make a one-time lump sum payment of \$1,000,000 to Sound Transit towards the development cost of Sound Transit's project consistent with Sound Transit's budget assumptions.
- City of Issaquah agrees to provide continuous police monitoring of Sound Transit's CCTV and customer emergency service ("panic button") stations for 20 years at no cost to Sound Transit.
- Sound Transit agrees to size its stormwater vaults large enough to detain and treat run-off from both Sound Transit's project and the future fire station.

• Sound Transit agrees to use its best efforts to provide approximately 160 interim parking stalls during construction of the Project.

BUDGET and FINANCIAL PLAN DISCUSSION

The current Board-adopted budget for this project is \$29,482,069, which includes all costs associated with this proposed interagency agreement between Sound Transit and the City of Issaquah. Also included in the proposed interagency agreement is a one-time lump sum \$1,000,000 contribution from the City of Issaquah towards development of the project. The \$1,000,000 contribution is included in Sound Transit's revenue budget.

There are no contingency funds required and no subarea impacts other than what is already assumed in the financial plan.

PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

The Issaquah Transit Center/SR900 project includes a 6-bay transit island and a parking structure with approximately 800 parking stalls at the existing Issaquah Park-and-Ride Lot (a five-acre site located on SR-900 between NW Newport Way and NW Maple Street).

CONSEQUENCES of DELAY

A two-week delay would not create adverse impacts on the project.

PUBLIC INVOLVEMENT

Sound Transit hosted a public open house on March 16, 2004 seeking input on a preferred project alternative. The feedback was strongly supportive of the structured parking alternative at this location.

Sound Transit hosted a public open house on March 20, 2003 for siting the Issaquah Transit Center/SR900 project. The feedback was strongly supportive of the site of the existing Issaquah SR900 Park-and-Ride Lot.

On September 15, 2003, the Issaquah City Council adopted Resolution No. 2003-11, Agenda Bill No. 5054. The Issaquah City Council directed City of Issaquah staff to proceed with the negotiations of an interlocal agreement with Sound Transit including the reservation of \$1,000,000 to be authorized within the 2004 to 2006 timeframe for payment to Sound Transit as the City of Issaquah's commitment to co-locate a fire station on the same site as the Issaquah Transit Center/SR900 project.
