# PROJECT NAME

Reservation to Freighthouse Square

## PROPOSED ACTION

Authorizes the Chief Executive Officer to execute a contract amendment with David Evans and Associates, Inc. for design services for Reservation to Freighthouse Square Embankment Remediation in the amount of \$206,254, with a 20% contingency of \$41,251, for a new total authorized contract amount not to exceed \$2,226,623.

# KEY FEATURES of PROPOSED ACTION

- The proposed action requires work which provides remediation of the structural earth wall embankment necessary to address settlement and design life expectancy of the track and embankment. It includes preparation of plans, contract specifications, and cost estimates for construction.
- This work will provide long term protection for the embankment and reduce the monitoring and maintenance requirements for the wall.
- The proposed action provides design services including final design.

# **BUDGET and FINANCIAL PLAN DISCUSSION**

Sound Transit has received funding to perform the design and construction of the retaining wall and is holding the funds in a claims account. Funding for this contract amendment will come from the claims account. Expenditures stemming from this contract amendment will be charged to the claims account.

# PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

Sounder revenue service started on the Reservation to Freighthouse Square segment in September 2003. Service was halted in January 2004 pending remediation of a portion of an embankment that experienced excessive settlement. Stage 1 of the remediation was completed in May 2004 and the track system was monitored. In June 2004, it was determined that further remediation work to stabilize the embankment was necessary. The work was performed in July 2004 and Sounder service was restored in August 2004. In January 2005, concrete wing walls were added to reinforce the embankment at the Bay Street Underpass abutments.

Sound Transit continues to perform monthly monitoring and surveying of the embankment. Its consultants have evaluated the embankment and recommended that a retaining wall be constructed along the portions of the wall that have experienced the most settlement.

David Evans and Associates, Inc. will design the retaining wall and Sound Transit's independent technical experts will review the remediation design and monitor the embankment until the remediation work is completed. It is anticipated that this third phase of remediation work will be constructed between March and September of 2006.

Sound Transit requires additional engineering services for the design of a supplemental structural wall system that supports the existing geo-synthetic structural reinforcing system within the earth embankment. The supplemental wall system will be designed so that Sounder operations will experience minimal disruption during the construction period.
