PROJECT NAME

Reservation Junction to Freighthouse Square

PROPOSED ACTION

Authorizes the Chief Executive Officer to execute a contract amendment to the existing sole source contract with HNTB Corporation to provide independent technical review services for the remediation project and continued monitoring of the earth fill embankment and track bed structure, and continued inspection of the track on the connection between Reservation Junction and Freighthouse Square, in the amount of \$269,649, with a 10% contingency of \$26,965, totaling \$296,614, for a new total authorized contract amount not to exceed \$1,110,459.

KEY FEATURES of PROPOSED ACTION

- Retains HNTB Corporation to provide independent review and expertise as the final remediation efforts proceed through design and construction.
- Provides for the continuation of the current monitoring plan regarding settlement concerns/projections that have been presented in the initial assessment, observed by actual site conditions, and accepted by all parties. The monitoring plan includes:
 - Surveying of the structural earth walls (SEW) once a month from January through March;
 - Geotechnical analyses of the SEW following inclinometer readings once a month from January through March;
 - Surveying of the SEW during construction of remediation;
 - Geotechnical analyses of the SEW following inclinometer readings during construction;

- Post-construction surveying and geotechnical analysis of the remediation project through December 2006;
- Compiling a final report summarizing the monthly reports, construction, and post construction reports submitted to Sound Transit, in addition to the ongoing monitoring and reporting; and
- Continued track inspection

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2006 project budget is \$16,802,131 with a final design phase budget of \$962,332 and a construction phase budget of \$14,887,175. The proposed action is to execute a contract amendment with HNTB Corporation in the amount of \$269,649 with a 10% contingency for a total of \$296,614. Of this total amount, \$145,914 is final design and \$150,700 is construction. This action will leave a remaining final design phase shortfall of \$81,443 and a construction phase balance of \$262,241. The remaining balance for the project will be \$923,943. Past remediation costs will be transferred to and paid out of the claims account, thereby freeing up budget to cover the shortfall in the final design phase.

There are sufficient funds to complete this action. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

Sounder revenue service started on the Reservation Junction to Freighthouse Square segment in September 2003. Service was halted in January 2004 pending remediation of a portion of an embankment that experienced excessive settlement. Phase 1 of the remediation was completed in May 2004 and the track system was monitored. In June 2004, it was determined that further remediation work to stabilize the embankment was necessary. The work was performed in July 2004 and Sounder service was restored in August 2004. In January 2005, concrete wing walls were added to reinforce the embankment at the Bay Street Underpass abutments as Phase 2 Remediation.

In October 2005 Sound Transit amended the contract with David Evans Associates, Inc. to obtain additional engineering services to design a supplemental structural wall system as Phase 3 Remediation. The Phase 3 Remediation will be designed so that Sounder operations will experience minimal disruption during the construction period.

Sound Transit has used HNTB Corporation and its subconsultants, Shannon & Wilson, to perform monthly monitoring and surveying of the embankment since 2003, and to assist Sound Transit with reviewing design and geotechnical issues.

As Sound Transit's independent technical experts, HNTB Corporation will review the Phase 3 Remediation design and monitor the embankment through construction of the remediation work as well as post construction. It is anticipated that this third phase of remediation work will be constructed between March and September of 2006.

Background:
