## PROJECT NAME

Lakewood Station

## PROPOSED ACTION

Authorizes the Chief Executive Officer to execute an agreement with the City of Lakewood establishing roles, responsibilities, terms and conditions regarding the development of the Lakewood Station Project.

## **KEY FEATURES OF PROPOSED ACTION**

- The proposed agreement is consistent with the terms and conditions established in the term sheet signed by Sound Transit and the City on August 25, 2005. Upon execution, the agreement will supersede all prior agreements, including the "Cooperative Agreement" executed on April 3, 2002.
- The agreement covers development standards, permits, construction, utility relocation, and ownership/responsibility for maintenance, security, and storm water detention and treatment facilities.
- The parties agree to cooperate and work in good faith toward completion of the project. A dispute resolution process is included to quickly and effectively settle disputes.
- The City will convey to Sound Transit at no cost a strip of land along Pacific Highway South for the project.
- The City and Sound Transit agree that the mitigation measures contained in the completed environmental documents and the agreement address all impacts.
- The project is vested to development standards established in the agreement.

- The City of Lakewood shall contribute the project's storm water detention and treatment facilities and shall operate and maintain them for a period of forty years, or until their replacement is required, at which time the parties agree to determine responsibilities for replacement.
- The City of Lakewood shall maintain the completed facility to Sound Transit's standards and shall provide facility-specific security for a period of forty years. The value of facility maintenance and security for this period is consistent with contributions considered in June 2005, when the Sound Transit Board increased the project budget to include structured parking.
- Sound Transit shall manage and fund the design and construction of the project using funds under its control pursuant to the terms and conditions and standards established in this agreement. The project will be designed and constructed to preserve the ability for future expansion. The final design of the project shall be determined, at Sound Transit's sole discretion, and within the adopted project budget.
