PROJECT NAME

Performance Measurement System

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Rene` Ewing & Associates, LLC to provide additional performance measurement consulting services in the amount of \$50,000, for a new authorized contract amount not to exceed \$343,295.

KEY FEATURES of PROPOSED ACTION

- The purpose of this action is to seek Finance Committee authorization to amend the contract for agency performance measurement consulting services.
- The scope of work will include the following:
 - Facilitate the transition to the new performance management system;
 - Facilitate the implementation of the new Sound Transit Agency Review (STAR) meetings for reporting on performance management;
 - Work with executives to develop strategy, scope, and agenda;
 - Provide background, resource identification, and implementation strategies to infuse into organizational systems;
 - Conduct a Values and Goals workshop with the executives and directors;
 - Provide coaching and technical assistance on measurement of performance initiatives;
 - Evaluate scorecards developed by Sound Transit departments and divisions against transit industry practice for effectiveness, economy, and efficiency of reported metrics;
 - Prepare report and brief Sound Transit executives and directors on how well these metrics and targets relate to transit agency operations;
 - Prepare a benchmarking report to succinctly identify performance management strategies of Sound Transit and other transit agencies

BUDGET IMPACT SUMMARY

Original contract scope is almost complete and this amendment is awaiting Finance Committee approval. The existing contract has been extended to December 31, 2006 to allow for completion and evaluation of all tasks.

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET AND FINANCIAL PLAN DISCUSSION

The Executive Department has an available contingency budget of \$115,000, which can be used for this purpose. The proposed action is consistent with the current Board-adopted budget and is affordable within Sound Transit's current long-term financial plan and the subarea financial capacity.
