PROJECT NAME

Central Link Light Rail Initial Segment

PROPOSED ACTION

Authorizes the Chief Executive Officer to execute a contract amendment with Carter & Burgess to provide construction management services for Link Light Rail Segment C735, Rainier Valley construction in the amount of \$4,293,570, for a new total authorized contract amount not to exceed \$12,944,305; and to exercise an option to extend the term of the contract to December 31, 2007.

KEY FEATURES of PROPOSED ACTION

- The contract scope includes: providing resident engineering, office engineering, inspection (civil, structural, electrical, track, mechanical, utilities), change order administration, safety inspection, management, and diversity support.
- The additional contract authority request is primarily a result of two main influences to the construction management contract added effort and extended construction period.
- This contract amendment is necessary to provide additional funding for:
 - Scheduling support. This configuration improves the integration of schedule management and analysis with overall construction management.
 - Extending the duration of the full time safety inspector providing support to Link's coverage during staffing changes within the organization and to address special construction issues on the project.
 - Special inspections required to satisfy permit requirements of the City of Seattle's Department of Planning and Development for retaining walls on private property.

- Additional field engineering support to expedite resolution of field questions and facilitate coordination of work.
- An assistant resident engineer to help manage the significant amount of contract documentation. This position also supports field operations, as required.
- Additional office engineering staff to help manage the large volume of change requests received from the construction contractor.
- Additional administrative staff to address the increased amount of project documentation.
- Additional field inspectors based on quality control issues experienced to date and based on the contractors work plan through the completion of the project.
- Time: The contractor's current schedule, as of July 18, 2006, forecasts completion in October 2007. The construction management contract expires on December 31, 2006. This proposal exercises one of three options to extend the contract by one year to December 31, 2007. The proposed budget will support construction management services through the current construction completion.
- Funding is proposed to be carried as a shortage in the 2006 budget and addressed in the Proposed 2007 Budget.

BUDGET and FINANCIAL PLAN DISCUSSION

The proposed action would authorize execution of a contract amendment with Carter & Burgess to provide construction management services for Rainier Valley C735 Construction in the amount of \$4,293,570 for a total authorized contract amount not to exceed \$12,944,305. This amount includes \$384,533 of work to be reimbursed by third parties under betterment agreements (Motion No. M2003-108). Approval of the proposed action would increase Sound Transit's total cost obligation to \$12,559,771.

The total adopted capital budget for the Initial Segment is \$2.07 billion. Within the construction services phase of that budget, the current approved budget for C735 construction management services is \$8,266,202. To date, commitments for this budget line item are \$8,264,124. Should the proposed action be approved, the commitments for C735 construction management services would increase to \$12,557,694, resulting in a shortfall of \$4,291,492 for this budget line item. Of this amount, \$2,417,199 would be offset by remaining surplus budget in the construction services phase. The proposed 2007 budget for the Initial Segment includes funding for the remaining \$1,876,371 budget shortfall. This action does not change the lifetime budget of the Initial Segment.

The contract with Carter & Burgess includes work that is part of the Central Link Initial Segment, as well as additional work to be reimbursed by the City of Seattle and private utilities, as authorized by prior board motions. Costs related to this additional work are not charged within the Link Initial Segment, but are tracked separately to facilitate project accountability and reimbursement. To date, a total of \$366,611 has been committed under this contract for betterment work, and increase of \$2,077. Sound Transit's share of the total work is decreased by this amount, and would be \$12,557,694 should the proposed action be approved.

Sound Transit's share of the proposed action is covered by the proposed 2007 capital budget for the Initial Segment, and is affordable within the agency's current long-term financial plan and subarea financial capacity. The proposed action will have no new revenue impact on Sound Transit.

In November 2001, the Board selected the Central Link Light Rail Initial Segment to be constructed from downtown Seattle to South 154th Street in Tukwila. Construction along MLK Jr. Way South includes 4.5 miles of at-grade light rail guideway and the Columbia City (Edmunds), Othello, and Rainier Beach (Henderson) Stations.

In December 2003, Sound Transit identified RCI-Herzog as the most responsive, responsible bidder for the C735 - Rainier Valley Construction procurement. RCI-Herzog's proposed baseline schedule projected completion of the work in January 2007.

In January 2004, Sound Transit issued a Notice to Proceed (NTP) to the Carter & Burgess contract for construction management services for the C735 - Rainier Valley Construction project. Services include providing resident engineering, office engineering, inspection (civil, structural, electrical, track, mechanical, and utilities), change order administration, safety inspection, management, and diversity. The contract period ends December 31, 2006, with three one-year options.

In February 2004, Sound Transit issued NTP1 for preconstruction work to RCI-Herzog, with a contractual completion date of April 2007. Construction management services are provided by Carter & Burgess.

In July 2004, Sound Transit issued NTP2 for the remaining work to RCI-Herzog. Soon after NTP2 was issued, additional staff was mobilized as a result of many factors, including the need to enhance the quality assurance inspections and manage increased contract documentation.

In July 2006, RCI-Herzog submitted a revised baseline schedule projecting work to be completed in October 2007 with the current construction completion of 48%. Sound Transit has not changed the contractual completion date from April 2007 and the responsibilities for the delay are not yet resolved.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the Chief Executive Officer to execute a contract amendment with Carter & Burgess to provide construction management services for Link Light Rail Segment C735, Rainier Valley construction in the amount of \$4,293,570, for a new total authorized contract amount not to exceed \$12,944,305; and to exercise an option to extend the term of the contract to December 31, 2007.

The proposed contract amendment is necessary to provide additional funding for scheduling support, safety inspection, geotechnical special inspections, field engineering, assistant resident engineering, office engineering, field inspection, administrative assistance, and contract change procedure review. It also exercises a one-year option to extend the contract to December 31, 2007 to cover the contractual completion date of the construction project.

Motion:

It is hereby moved by the Board of the Central Puget Sound Regional Transit Authority that the Chief Executive Officer is authorized to execute a contract amendment with Carter & Burgess to provide construction management services for Link Light Rail Segment C735, Rainier Valley construction in the amount of \$4,293,570 for a new total authorized contract amount not to exceed \$12,944,305; and to exercise an option to extend the term of the contract to December 31, 2007.
