PROJECT NAME

Professional Janitorial Services

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Yarisbey Rumbaut and Jose Jauregui, doing business as Buena Vista Cleaning Services, to provide professional janitorial services and exercise two one-year options to extend the term of the contract in the amount of \$380,633, for a new total authorized contract amount not to exceed \$551,823.

KEY FEATURES of PROPOSED ACTION

- Yarisbey Rumbaut and Jose Jauregui, formerly doing business as Moe's Cleaning Service and now doing business as Buena Vista Cleaning Services, currently provides janitorial services at Union Station under a contract effective November 21, 2005. The contract is for a one-year term with two options; each extending the term of the contract for an additional year.
- The current contract expires on November 30, 2006. This action will permit the chief executive officer to exercise the first option to extend the term of the agreement to November 30, 2007. The chief executive officer may authorize the execution of the second option year extending the contract to November 30, 2008, as the contractor's performance in the first option year may warrant.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET TABLE

The proposed contract extension is funded through a combination of existing budget from the Adopted 2006 Budget, page 193 of the 2006 budget book, as well as future budgets that would be provided for in 2007 and 2008. The impact of this contract on the proposed future budgets is illustrated below:

Notes

1 Represents the portion of the maintenance of stations budget from page 193 of the Adopted 2006 Budget. The total budget for maintenance services is \$518k, of which \$148K is related to daily cleaning services.

2 Committed to date per expenditures incurred through October, 2006, plus additional work that has been performed but not billed.

3 This contract would add \$381K to the expenditure, of which \$15K would be anticipated to be spent in 2006.

4 Represents the amount expected to be included in the 2007and 2008 transit operations budget for daily cleaning services. This amount would be available to fund the remaining balance of the proposed contract.

BUDGET and FINANCIAL PLAN DISCUSSION

The original contract with Buena Vista Cleaning Services was executed in 2005 in the amount of \$171,189. Through October 31, 2006, a total of \$158,000 has been either spent or committed on this contract. These expenses are funded in the Union Station division staff operations budget, which is included in the Transportation Services Department budget.

For 2006, a total of \$148,100 was budgeted for services under this contract, of which a total of \$122,399 was paid through October 31, 2006. The current contract expires on November 30, 2006. The proposed extension would be for two years and covered under the next two years operating budgets. For 2007, the proposed budget available to cover this contract is \$189,000. While the 2008 budget has not yet been developed, the contract extension would require a 2008 budget of \$210,000, which will be included in the 2008 staff operations budget planning. This amount is affordable within the finance plan.
