PROJECT NAME

Central Link Light Rail Initial Segment

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Valley Freightliner, Inc. for the purchase of four non-revenue vehicles to support Central Link light rail operations and maintenance activities for a total authorized contract amount not to exceed \$915,683.

KEY FEATURES of PROPOSED ACTION

- The proposed action will authorize the purchase of four high-rail vehicles to provide support for Central Link light rail operations and maintenance activities; specifically, one track truck, two bucket trucks for use by Link light rail operations and maintenance, and one flatbed truck with crane for use by way, power, signals, and facilities.
- A budget of \$2,000,000 was established for procurement of approximately 22 non-revenue vehicles. In May 2006, an initial action was approved by the Finance Committee for procurement of a car mover out of this budget. In December 2006, two of the three electric carts were procured. In May 2007, the action to procure an initial fleet of seven diesel trucks was approved. One of the vans was also procured through the state contract. A balance of \$1,084,210 remains for procurement of the remaining ten vehicles. In lieu of purchasing one bucket truck and one platform truck, two bucket trucks will be procured upon approval of this action.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2007 Budget for the Central Link Initial Segment is \$2.07 billion. Within that amount, \$2.0 million has been set aside for P812 Procurement of Non-Revenue Vehicles in the construction phase. When added to current commitments, the proposed action would increase this amount by \$915,682 to \$1,825,462, and leave a remaining balance of \$174,538 for this budget line item.

The proposed action is consistent with the current adopted budget, and is affordable within the agency's long-term financial plan and subarea financial capacity. The action will have no new revenue impact on Sound Transit.

Beyond the proposed action, Sound Transit will need to purchase eight (8) remaining nonrevenue vehicles for the Initial Segment project. Should the proposed action be approved, the remaining budget balance for P812 Procurement of Non-Revenue Vehicles would fall short of the estimated costs to purchase these vehicles by approximately \$160,000. This shortfall will be funded from surplus budget for P811 Maintenance Equipment within the construction phase as part of the 2008 Budget update.

Sound Transit issued an Invitation for Bid for the purchase of four high-rail specialty vehicles. Two bids from Valley Freightliner Inc. were received, each with Valley Freightliner as the prime with a different supplier. The bid price was analyzed and determined to be fair and reasonable. The price was higher than the independent cost estimate which was based on 2005 dollars.
