## PROJECT NAME

Citizen Oversight Panel Appointment

#### PROPOSED ACTION

Approving the appointments of David A. Russell and Robert M. Goldstein to the Citizen Oversight Panel for a term of four years beginning March 2007 and expiring March 2011.

## KEY FEATURES of PROPOSED ACTION

- The purpose of this action is to fill two vacancies on the Citizen Oversight Panel (COP). In December 2006, Bertha Eades retired after service of the maximum two terms expired. Ms. Eades represented the East King County subarea. In April 2006 Lynn Guttmann, who represented the Seattle/North King subarea, resigned.
- Applications and accompanying resumes were mailed to Board members on November 20, 2006. Ms. Burleigh and Mr. Phillips have placed their support for Mr. Russell's appointment. Mr. Phillips has placed his support for Mr. Goldstein's appointment.
- This motion is being brought directly to the Board for action prior to the next Executive Committee meeting scheduled on April 5, 2007 to expedite the process to fill two of four vacancies enabling the Panel to sufficiently represent the community. Staff is currently conducting a new recruiting effort.
