# PROJECT NAME

Contract with Dell for Technology Hardware for 2008

# PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Dell, Inc. to provide hardware maintenance and procurement services for a total authorized contract amount not to exceed \$600,000.

# KEY FEATURES of PROPOSED ACTION

- Procurements will include the replacement of aging hardware and purchase new hardware for approved agency projects for both FTE and consulting staff of approximately 800.
  - Aged hardware replacement, include workstations, monitors and servers as follows:
    - Workstation: 3 Years
    - Monitor: 3 Years
    - Server: 3 5 Years
  - Hardware requirements for projects approved by Sound Transit's Technology Steering Committee.
- This contract piggy-backs on the Western States Contracting Alliance (WSCA) for Dell Business Solutions Hardware. Using the agreement allows Sound Transit to take advantage of a 15% to 40% discount afforded by this multi-agency procurement mechanism.
- Sound Transit has procured technology hardware through a similar method for the past four years; each with an annual contract to cover the year's expected expenses.

# **BUDGET IMPACT SUMMARY**

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET and FINANCIAL PLAN DISCUSSION**

The proposed action is consistent with the current adopted budget and is affordable within the agency's long-term financial plan and sub area financial capacity. The action will have no new revenue impact on Sound Transit.

The Dell contract includes \$200,000 for capital and \$400,000 for expense procurements. Procurements will be charged to both IT and other department budgets.

Servers over \$5,000 each are budgeted with the administrative capital budget on page 223 of the Board-Adopted 2008 Budget book. Capital Technology for projects will be charged, as requested, to the agency administration phase of the appropriate project provided it is demonstrated that there is sufficient budget with in the project phase. The agency administration phase budget can be found on pages 89, 107, and 135 of the Board-Adopted 2008 Budget Book for Link, Sounder, and Regional Express respectively. Work Stations and monitors are expense items and are included within the materials and supplies line item on page 178 of the Board-Adopted 2008 Budget.
