PROJECT NAME

Bothell Branch Campus Access

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with INCA Engineers, Inc. to provide additional final design construction support and construction management services for the Bothell Branch Campus Access project in the amount of \$73,055, with a 10% contingency of \$7,305 totaling \$80,360, for a new total authorized contract amount not to exceed \$499,420.

KEY FEATURES of PROPOSED ACTION

- Provides for additional dollars to complete design construction support work and construction management services. The original design construction support and construction management services were authorized by the Finance Committee in February 2006.
- The scope of work for these services is the same as in the original contract: it includes
 review and approval of shop drawings and submittals, responding to RFIs, coordinating with
 Snohomish County PUD and the City of Bothell for utility arrangements, close out of the
 construction contract, preparation of operations and maintenance manuals, preparing asbuilt drawings and a final closeout report.
- After completion of the construction, in excess of \$1 million dollars is projected to be returned to the East King County Reserve during the 2009 budget process.

BUDGET IMPACT SUMMARY

Current Project Phase: Construction Projected Completion Date: June 2008

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2008 Budget for this project is \$3,859,857, with a construction phase budget of \$2,062,187. The proposed action is to amend the contract with INCA Engineers, Inc. in the amount of \$80,360, for a new total authorized contract amount not to exceed \$499,420. This action leaves a remaining construction phase balance of \$1,022,670 and a project balance of \$2,105,135.

There are sufficient funds to complete this action. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

The Bothell Branch Campus Access project will improve transit access to the University of Washington/Cascadia Community College Campus from I-405 via NE 195th Street. The project will include signalization of the north campus loop, rechannelization of North Campus Road, rechannelization of Campus Way NE, modification of the north loop curb and sidewalk. These improvements will provide for more efficient transit movements in to and out of the campus and will expand the operational capacity for regional and local transit service.

Construction of this project was split into two phases to accommodate the schedule for long-lead items – the signal light poles and traffic signal controller. Kemper Construction Corporation began work in July 2007, and completed the first phase of construction in November 2007. Phase 1 included the earthwork and underground utility work – which are typically the high risk items on any construction job – and the rockeries and walls. The goal was to complete this work before shutting down for the wet winter months and then wait for the signal poles to arrive for installation. Phase 1 was completed as scheduled and with no change orders, but required extra effort by design and construction management team.

The construction team spent a great deal of unanticipated hours working with the contractor to complete the first phase of the construction before the winter rains. The contractor's original schedule did not complete the earth work in time for the winter weather. In addition, there were several reviews, rejections and re-submittals of the proposed traffic control plans, safety plans, the contractor's methods of construction and other contract requirements. Additional coordination with the power and telephone providers was also required due to a delay in starting the construction. With there being only one access point into the campus, the construction management team continues to spend additional hours working with the contractor to schedule work elements for minimal disruption and traffic impacts.

Other challenges faced by the design team included significant inconsistencies between what was found in the field versus what was shown on the existing campus as-built drawings. An example of the additional work required is re-creating a campus wiring diagram when it became obvious what had been constructed did not match the original campus construction plans. The team had to re-create wiring plans to connect the new signal equipment properly.

The original contract contingencies were used for these efforts as well as for additional traffic modeling requested by King County Metro.

Phase 2 construction is scheduled to start in first quarter 2008 and be complete in the second quarter of 2008. Work will include installation of the traffic signal poles, traffic signal controller, real time technology, final paving, and landscaping. This work will require the continued INCA/KBA team oversight. The proposed amendment includes funding for the continued construction management, shop drawings review and approval and coordination with the City of Bothell utilities group, Snohomish County, who will operate the traffic signal, and both the University of Washington and Cascadia Community College.

The contract amendment also includes the cost to close out the project which includes closing all contracts, and resolving any outstanding issues, ensuring as-built drawings are completed, and verifying/ transferring all warranties.

With the completion of the Phase 2, the project is projected to be in a position to return over \$1 million dollars back to the East King County Reserve. This is in addition to the \$3 million dollars that was returned to the Reserve from the project in 2004.

The project improvements will be turned over to the UW/CCC for ownership, maintenance and operation after construction.
