PROJECT NAME

Issaquah Transit Center/SR 900

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Harbor Pacific Contractors, Inc. to complete construction of the Issaquah Transit Center/SR 900 project in the amount of \$414,000, with a 10% contingency of \$41,400 totaling \$455,400, for a new total authorized contract amount not to exceed \$20,484,699.

KEY FEATURES of PROPOSED ACTION

- The purpose of this action is to amend the Harbor Pacific Contractors, Inc. contract increasing it by \$455,400 required to complete the construction contract and open the transit center garage. There are sufficient funds to allow this action within the construction project budget.
- The Issaquah Transit Center/SR 900 project includes a new transit center with a four story parking garage for 800 cars, and a transit island with six bays. Harbor Pacific Contractors completed construction and opened the transit island for service in June. The garage completion is anticipated at the end of July and offsite wetland mitigation completion is anticipated in November 2008.
- Based on current contract changes, the estimated cost to complete the garage and remaining wetland mitigation work will exceed the current authorized amount.
- A number of factors have driven the need to increase the project budget including bad soils, bad weather, underground utilities, and a higher than anticipated static ground water table level.

BUDGET IMPACT SUMMARY

Current Project Phase: Construction Projected Completion Date: 2008

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2008 Budget for this project is \$29,482,069, with a construction phase budget of \$22,361,261. The proposed action is to amend the Harbor Pacific Contractors, Inc. contract increasing it by \$455,400 to provide construction services. The proposed action would leave an uncommitted construction phase balance of \$246,115, and a balance for the project of \$1,562,107.

There are sufficient funds to complete this action within the project's construction phase budget. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

- Harbor Pacific Contractors, Inc. is the prime contractor for this contract and is a small business firm. 78% of this contract to date has been performed by small business and 11% by WBE/DBE.
- Harbor Pacific Contractors, Inc. committed to a 56.6% Small Business goal and a 12.1% M/W/DBE goal.

• Harbor Pacific Contractors, Inc. workforce demographics are 9% women and 15% minorities.

Apprentice Utilization Commitment

• The apprenticeship utilization goal on this project was 20%. Harbor Pacific Contractors, Inc. has utilized 24% of apprenticeship to date. This will continue through completion.

A number of factors have driven the need to increase the project budget including bad soils, bad weather, and underground utilities. During design development, the project site was determined to have marginal soil conditions, potentially unacceptable for supporting the new work. Unit price bid items were included in the contract to provide competitive pricing for the work associated with the high risk soil conditions. Final quantities on these bid items exceeded the assumed amounts. Similar unforeseen soil conditions not directly applicable to the bid items and a higher than anticipated static ground water table level increased contract costs by an additional \$300,000.

The City of Issaquah has contributed \$1 million in a lump sum payment towards the cost of the project. At the completion of the project, Sound Transit will dedicate a one-half acre parcel to the City of Issaquah for future development of an Eastside Fire and Rescue Station.
