PROJECT NAME

Everett Station Phase 2

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Zimmer Gunsul Frasca Architects, LLP to provide as-built drawings for the Everett Station Phase 2 project in the amount of \$29,974 for a new total authorized contract amount not to exceed \$1,973,411.

KEY FEATURES of PROPOSED ACTION

 The Phase 2 final design contract with Zimmer Gunsul Frasca Architects, LLP (ZGF) did not include asbuilt drawings in the scope of work required for the project. This action will provide additional funds to complete the final task for this project.

BUDGET IMPACT SUMMARY

Current Project Phase: Construction Projected Completion Date: 2009

There is no action outside of the Board-Adopted 2009 Budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The Adopted 2009 Budget for Everett Station is \$33,956,653 with a construction phase budget of \$21,772,899. The proposed action is to amend the construction support services contract with ZGF increasing it by \$29,974. The proposed action will leave a construction phase balance of \$1,281,267 and a project balance of \$1,555,620.

There are sufficient funds to complete this action within the both project's budgets. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

Everett Station is a multimodal station accommodating Amtrak, Greyhound, Everett Transit, Community Transit, ST Express Bus, Sounder Commuter Rail, charters, taxis, and shuttles.

Sound Transit contracted with ZGF to be the designer of record for all phases of the Everett Station project. This work was divided into two phases: the first phase included the Amtrak platform, a portion of the station track and commuter rail platform. It was completed and has been in service since December 2003.

Construction is nearly complete for the final phase, Phase 2 (East Side) of the station; including the 440-stall east parking lot, a pedestrian bridge over the tracks, pedestrian access plazas on both sides of the tracks, completion of the 330-stall south parking lot, and an operations building for light maintenance equipment and

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract amendment with Zimmer Gunsul Frasca Architects, LLP to provide as built drawings for the Everett Station Phase 2 project in the amount of \$29,974 for a new total authorized contract amount not to exceed \$1.973,411.

Background:
