PROJECT NAME

On-Call Environmental and Sustainability Management Services Contract

PROPOSED ACTION

Authorizes the chief executive officer to execute a five-year contract with Paladino & Company, Inc. to provide environmental and sustainability management services on an as-needed basis in the amount of \$500,000, for a total authorized contract amount not to exceed \$500,000.

KEY FEATURES of PROPOSED ACTION

- The purpose of this contract is to assist the agency, on an as-needed basis, with a broad array of services related to implementing and advancing the agency's Sustainability Initiative. Such services include developing an agency-wide sustainability program, identifying specific near-term and long-term strategies and action plans, and integrating sustainability into agency plans, projects, designs, construction activities, facilities, and operations.
- This action is needed to assist the agency in its efforts to continue to be a regional and national leader in the transit industry in implementing sustainability measures. The consultant team will help the agency develop measures and means of quantifying the value of the sustainability program and Environmental and Sustainability Management System (ESMS) to the agency.
- The scope of work includes services related to addressing climate change and global warming issues, such as assisting the agency with analyzing, reducing, and reporting its Greenhouse Gas (GHG) emissions, evaluating displaced and avoided emissions, monitoring climate policy and emerging laws and regulations, and assisting the agency in developing and implementing a system-wide program for emissions reduction, renewable energy, energy conservation, and energy cost savings.
- The scope of work also includes assisting with the on-going administration of the agency's ISO 14001 certified ESMS. This work will include, but is not limited to, conducting internal compliance and management system audits, developing objectives and targets, implementing corrective actions, updating ESMS procedures and documents, and assisting in maintaining Sound Transit's ISO 14001 Certification. This action is needed because the existing ESMS services contract with Environmental Resources Management (ERM) is expiring and all funds have been allocated.

BUDGET IMPACT SUMMARY

The budget for both the capital and operating costs have been included within the adopted budgets; there is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The proposed action will authorize a five-year contract. 2009 services procured under this contract will be obtained within Board-adopted budgetary levels.

Budget for Consultant Services is found within the Legal Division Staff Operating Budget Service account group under the following accounts Consultant / Management, Legal, and Other Services and is primarily found within Legal Division Staff Operating Budget on page 204 of the Adopted 2009 Budget. Costs for future years will be included in the Planning, Environment, and Project Development Department's Office of Environmental Affairs and Sustainability Staff Operating Budget under Consultant Services.

In 2004, Sound Transit adopted an Environmental Policy and was among the first wave of transit agencies to develop and implement an Environmental and Sustainability Management System (ESMS). In June 2007, the Sound Transit Board of Directors passed Resolution No. R2007-12 establishing a Sound Transit Sustainability Initiative, which is consistent with the commitments in Sound Transit's Environmental Policy and which authorized the chief executive officer to establish a Sound Transit Sustainability Initiative. This Board Resolution set the framework for a comprehensive approach to addressing sustainability throughout the agency and strengthened Sound Transit's environmental commitment as part of continual improvement and in response to diminishing natural resources and the impact of global warming. The Sustainability Initiative also reinforced the agency's commitment to integrating sustainable business practices throughout the organization. The Sustainability Initiative addresses a wide-range of topics, including fuels, vehicles and emissions, ecosystem protection, green procurement, recycling and waste prevention, energy and water conservation, and sustainable design and construction.

Paladino and its team of subconsultants will assist the agency, on an as-needed basis, with a broad array of services related to (1) implementing and advancing the agency's Sustainability Initiative, (2) addressing climate change/global warming issues, and (3) assisting with the on-going administration of the agency's ISO 14001 certified Environmental and Sustainability Management System.

CONSEQUENCES of DELAY

A delay in the approval of this contract will require postponing certain elements of the agency's ISO 14001 certified ESMS, such as the internal management system and environmental compliance audit, and will limit the resources available to further implement the Sustainability Initiative and to work on climate change and global warming issues affecting the agency. All funds have been allocated for the current ESMS services contract, which is soon expiring and which has a more limited scope.

PUBLIC INVOLVEMENT

Staff has worked with partners and the public through conferences, events, and networking groups to promote sustainability. On an as-needed basis, Paladino will represent and advocate on the agency's behalf regarding climate policy and requirements and may assist in developing outreach and marketing plans, within agency standards and overseen by Communications and External Affairs staff, to communicate the agency's climate plan and the environmental benefits of transit.
