PROJECT NAME

Sounder Commuter Rail Seat Replacement Project

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Sedia, Inc. to procure materials and assemble passenger seat cushions for Sounder passenger cars for a total contract amount not to exceed \$4,654,203.

KEY FEATURES of PROPOSED ACTION

- Authorizes contractor to procure material and assemble passenger seats for replacement on the Sounder passenger car fleet.
- The first Sounder passenger cars were placed in revenue service over nine years ago; this action will provide up to 148 new seats on the entire fleet of 58 Sounder passenger cars.
- The project will be implemented over five years to optimize the useful life of existing seats.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The proposed contract would be funded by the Sounder transit operations budget. The plan calls for seat replacement in the entire fleet over a five year period.

Specifically, the procurement of the foam will be initiated, materials received and the expense funded by the 2009 Sounder materials and supplies budget line item.

Work in 2010 and beyond will be funded through future transit operations budgets. For 2010, the work identified has a projected cost of \$373,000. This scope has been fully incorporated into the planning for the

Proposed 2010 Budget as published earlier this month. For work occurring in years beyond 2010, the budget will be included in future years' operations budgets. This item has been fully incorporated in agency financial planning. The total cost of the project is estimated to be \$4,654,203 over 5 years.

BUDGET TABLE

The proposed contract would be funded by the Sounder transit operations budget as published on Page 60 of the Adopted 2009 Budget, as well as by future years operating budgets. The impact of this transaction on the operations budgets is illustrated below:

The overhaul on all 58 Sounder cars will be completed within five years or by the end of 2013. Seat replacement will begin with cars that have been in service the longest and seats will be replaced in all the vehicles by the end of 2013.

Sound Transit will procure a vendor to install the new seats locally under a separate contract.

CONSEQUENCES of DELAY

The most significant consequence of delay will be customer discomfort, complaints from our passengers and modal image degradation.
