## **PROJECT NAME**

Layover Project

### **PROPOSED ACTION**

Authorizes the chief executive officer to execute a contract with SCI Infrastructure for construction of the Everett Layover Track Extension Project for Sounder in the amount of \$1,956,850, with a 10% contingency of \$195,685, for a total authorized contract amount not to exceed \$2,152,535.

#### **KEY FEATURES of PROPOSED ACTION**

- The Everett Layover Track Extension project adds storage capacity that will allow Sound Transit to store and maintain four full train sets supporting all four round trips between Everett and Seattle that are now in service.
- The project includes the layover track extension, track improvements, retaining walls, permanent intertrack fence, installation of under-drains, storm drains, sewer, water, air compressor, wayside power, lighting, and roadway access improvements.

## **BUDGET IMPACT SUMMARY**

Current Project Phase: Construction

Projected Completion Date: 2010 (Snohomish County portion)

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

## **BUDGET and FINANCIAL PLAN DISCUSSION**

The Adopted 2010 Budget for the project is \$26,811,657, with a construction phase budget of \$22,772,096. The proposed action is to execute a contract with SCI Infrastructure for construction of the Everett Layover Track Extension project in the amount of \$2,152,535. This action will result in a construction phase balance of \$2,531,860 and a project balance of \$3,533,763.

There are sufficient funds to complete this action within the project budget. Committing these funds will not endanger any other project elements that are to be funded out of the overall project.

### PROJECT DESCRIPTION and BACKGROUND for PROPOSED ACTION

Sound Transit currently provides Sounder service between Everett and Seattle on the BNSF Railway's railroad right of way. The Sound Transit and BNSF Railway Agreement allows Sound Transit a maximum of four round train trips. Service between Everett and Seattle began in December 2003. Sound Transit has added additional service in phases, with Train 2 beginning service in September 2004, Train 3 in September 2007, and Train 4 in September 2008.

The track extension project will increase train storage capacity to accommodate the full length (locomotive and four cars) of four Sounder train sets. Currently, the four short train (locomotive and two cars) sets are stored at the existing layover track at the Everett Station. The project also makes provisions for wayside power and air, security lighting, security fencing, storm drainage and roadway access improvements. The project will be completed by the first quarter of 2011. Sound Transit already possesses all of the train cars needed to support the four round trips between Everett and Seattle.

Environmental documentation for the Everett Layover Track Extension project is complete. Environmental impacts resulting from the Everett Station and vicinity improvements, including the layover track, were addressed in the Everett Multimodal Transportation Facility NEPA EA/SEPA EIS (1995) issued by the City of Everett and the Everett-to-Seattle Commuter Rail Final EIS issued by FTA and Sound Transit (December, 1999). A Finding of No Significant Impact (FONSI) was issued for the City's environmental document and the Everett-to-Seattle Commuter Rail Project received a Record of Decision (ROD) from FTA in February 2000. Sound Transit also issued a SEPA Addendum on June 7, 2005 and had a NEPA reevaluation approved by FTA on June 7, 2005 for the Everett Station East Parking Lot.

#### **CONSEQUENCES of DELAY**

A two week delay would not create a significant impact to the project schedule.

# **PUBLIC INVOLVEMENT**

The construction project is within the BNSF Railway's right of way and Sound Transit has obtained a temporary construction easement from the adjacent property owner. Sound Transit will provide an outreach update to the local businesses and residences once the contractor's construction schedule becomes available for distribution.

A motion of the Finance Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract with SCI Infrastructure for construction of the Everett Layover Track Extension Project for Sounder in the amount of \$1,956,850, with a 10% contingency of \$195,685, for a total authorized contract amount not to exceed \$2,152,535.

## Background:

Sound Transit currently provides Sounder service between Everett and Seattle on the BNSF Railway's railroad right of way. The Sound Transit and BNSF Railway Agreement allows Sound Transit a maximum of four round train trips. Service between Everett and Seattle began in December 2003. Sound Transit has added additional service in phases, with Train 2 beginning service in September 2004, Train 3 in September 2007, and Train 4 in September 2008.

The track extension project will increase train storage capacity to accommodate the full length (locomotive and four cars) of four Sounder train sets.
