PROJECT NAME

Technology Hardware Purchase and Maintenance Services

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Dell, Inc. for technology hardware purchases and hardware maintenance services for a total authorized contract amount not to exceed \$800,000.

KEY FEATURES of PROPOSED ACTION

- Procurements will include the replacement of aging hardware and the purchase of new hardware for approved agency projects for both full-time employees and consulting staff of approximately 900.
 - Replace aged hardware, including workstations, monitors and servers as follows:

Workstation: 4 YearsMonitor: 4 YearsServer: 3 – 5 Years

- Meet hardware requirements for projects approved by Sound Transit's Technology Steering Committee.
- The request includes sufficient funds for planned 2010 staff and consultant growth.
- This contract piggy-backs on the Western States Contracting Alliance (WSCA) for Dell Business Solutions Hardware. Using the agreement allows Sound Transit to take advantage of a 15% to 40% discount afforded by this multi-agency procurement mechanism.
- Sound Transit has procured technology hardware through a similar method for the past six years; each with an annual contract to cover the year's expected expenses.

BUDGET IMPACT SUMMARY

There is no action outside of the Board-adopted budget; there are no contingency funds required, no subarea impacts, or funding required from other parties other than what is already assumed in the financial plan.

BUDGET and FINANCIAL PLAN DISCUSSION

The proposed action is consistent with the current adopted budget and is affordable within the agency's long-term financial plan and subarea financial capacity. The action will have no new revenue impact on Sound Transit.

\$400,000 will be charged to the Administrative Capital Budget and \$400,000 will be charged to other department budgets.

Servers over \$5,000 each are budgeted with the Agency Administrative capital budget located on page 6 of the Adopted 2010 Transit Improvement Plan budget book. Capital Technology for projects is charged, as requested, to the agency administration phase of the appropriate project provided that it demonstrates sufficient budget within the project phase.
