PROPOSED ACTION

Authorizes the chief executive officer to execute a one-year contract with Parsons Brinckerhoff to provide initial project development services for the Sounder Yards & Shops Facilities project in the amount of \$807,372, with a 10% contingency of \$80,737, for a total authorized contract amount not to exceed \$888,109.

KEY FEATURES

- This proposed action is consistent with the 2011 Transit Improvement Plan and the capital program realignment process.
- This contract will provide information about options for the Sounder Yards & Shops Facilities project and will assist with 2012 budget development for the project.
- The contract amount includes an initial phase consisting of two task orders:
 - 1. Confirm Fleet and Operating Assumptions through 2030, and
 - 2. Facilities and Site programming (including preliminary site analysis and an assessment of the potential suitability of alternative project delivery methods).
- An additional five task orders were included in the advertised scope of work. These task orders
 include environmental documentation, preliminary design, and an option for final design, subject to
 Board action, to take advantage of efficiencies that could result from the consultant's knowledge
 gained during the project development phase of the contract.
- Following completion of the initial two task orders, the Board will consider the findings and make a decision about whether or not to proceed with the project and complete the remainder of the task orders.
- The completion of task orders one and two are expected to take approximately one year, however the majority of the work will be completed within six months.
- The Sounder Yards & Shops Facilities project is included in the voter-approved ST2 plan. As an ST2 project, the Sounder Yards & Shops Facilities project has passed through Gate 1 of the Agency's Phase Gate process for capital project management; Gate 1 formally creates a capital project within the agency's management systems and approves the project for entry into the project development phase for alternatives analysis.

PROJECT DESCRIPTION

The purpose of the Sounder Yards & Shops Facilities project is to provide sufficient capacity to store, and maintain the existing and future Sounder locomotives, coaches and cab cars projected through at least 2023.

In an effort to evaluate and ultimately improve Sounder commuter rail operations and maintenance cost efficiencies, ST2 included funding for review and evaluation of commuter rail vehicle storage and maintenance requirements and strategies and ultimately for design and construction of additional operations and maintenance facilities.

The Adopted 2011 Budget includes funding for planning and analysis, environmental documentation, and preliminary engineering for yard and shop facilities needed to support existing service as well as expanded levels of service anticipated by ST2.

SMALL BUSINESS PARTICIPATION

Sound Transit Goal: 16%

Commitment: 6% for task orders 1 and 2; 16% will be achieved for the contract if task orders 3-7 are completed.

Parsons Brinckerhoff is the prime consultant for this contract. They committed to a 16% Small Business goal for the entire contract. Since Sound Transit is directing Parsons Brinckerhoff to proceed with a contract including only task orders 1 and 2, and the majority of hours for small business firms were planned for tasks 5 and 6, environmental documentation and preliminary design, the commitment cannot be met on these task orders. Parsons Brinckerhoff commits that, for task orders 1 and 2 only; they will achieve 6% Small Business participation.

If the Board directs an amendment to the contract to complete all the tasks, the 16% commitment will be met.
