# **Department of Revenue Sales and Use Tax Collection**

### **PROPOSED ACTION**

Authorizes the chief executive officer to execute a contract with the Washington State Department of Revenue to administer and collect Sound Transit's sales and use tax and rental car tax and to compensate the Department for its services.

#### **KEY FEATURES**

The proposed contact is for three years, but will automatically renew for three-year periods through 2029, unless either the department or Sound Transit terminates the contract. Sound Transit will reimburse the Department an agreed amount to compensate for the cost to collect the tax. The collection and administrative costs are estimated to be \$73.8 million over the 18-year contact term, including \$1,420,383 for the State's 2011 fiscal year (July 2010-June 2011).

The proposed contract requires Sound Transit and the Department to negotiate in good faith to amend the contract terms to address unforeseen future events.

The services provided by the Department will include:

- collect and record taxes,
- provide monthly tax collection and distribution reports,
- perform taxpayer audits,
- identify, assess and collect unreported or underpaid taxes
- assist and educate taxpayers on proper tax reporting and payment,
- refunds overpaid taxes,
- allocate unidentified taxes,
- redistribute incorrectly allocated taxes,
- assist the State Treasurer in monthly distribution of taxes to Sound Transit, and
- provide other incidental functions necessary or appropriate to administer Sound Transit taxes.

## **FISCAL INFORMATION**

This cost is included in, and affordable under the agency's current financial plan. Budget for 2011 expenditures under this agreement is included in the adopted staff budget. Future years' expenditures will be requested within subsequent annual staff budgets.

#### **BACKGROUND**

Sound Transit's enabling legislation authorizes Sound Transit to contract with the Washington State Department of Revenue for the administration and collection of the retail sales and use tax and the rental car sales tax approved by voters in the Sound Transit District in 1996 and 2008. The Department of Revenue has performed this function for Sound Transit for the past 15 years under two successive contracts in which Sound Transit paid the Department for the capital infrastructure to collect the taxes, and agreed to pay any incremental collection and administration costs for additional services. The proposed contract adds reimbursement compensation for operational costs based on the historical cost to perform the services. The Department of Revenue is the only agency with the infrastructure to collect the taxes.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract with the Washington State Department of Revenue to provide tax collection and administration services and to compensate the Department for its services.

### **BACKGROUND:**

Future years' expenditures will be requested in subsequent annual staff budgets.
