PROPOSED ACTION

Authorizes the chief executive officer to execute a three-year contract with one two-year option to extend with HNTB Corporation to provide on-call project review services for a total authorized contract amount not to exceed \$1,700,000.

KEY FEATURES

- The scope of the contract provides for consultant services to perform independent reviews for individual construction contracts in the ST2 program. Services include:
 - Value engineering
 - Constructability reviews
 - o Risk analysis
 - o Independent project control services
- Services under this on-call contract will be authorized through the issuance of task orders that
 will define the detailed scope and schedule of the work to be performed. Funding for these
 task orders will come from established project budgets for which these services are being
 provided.
- The contract amount requested is intended to cover the initial three-year contract and does not include funding the two-year option.

PROJECT DESCRIPTION

As design of ST2 projects move forward, a number of independent reviews will be needed to confirm that designs are cost effective and can be built without significant risk of cost and schedule overruns. These processes are essential to successful execution of large and complex projects and are required by the FTA on federally funded projects.

FISCAL INFORMATION

This on-call contract will be used for Sounder, ST Express, and Link projects. Funding for this contract will come from the preliminary engineering and final design phases within the overall capital project budgets. The services described in the proposed action will be assigned on a task order basis after available budget is verified. Since the proposed services will be assigned on an as-needed basis, the distribution of costs will be determined as project schedules and budgets are established.
