## **PROPOSED ACTION**

Authorizes the chief executive officer to execute a one-year contract with two one-year options to extend with McBee Strategic to provide federal relations consulting services for a total authorized contract amount not to exceed \$1,483,632.

# **KEY FEATURES**

- McBee Strategic will provide federal relations consulting services through frequent consultations with Sound Transit and interactions on behalf of the agency with the federal legislative and executive branches of government.
- The amount requested is sufficient to cover the one-year contract and the two option years. Following the first year of the contract, staff will determine whether to exercise an option year or procure a new contract for these serves. The costs reflect a \$40,000 monthly retainer for the services of the firm.
- The current federal relations consulting contract will expire on December 31, 2011.

## **PROJECT DESCRIPTION**

Federal relations consulting services will provide the agency with strategic planning and coordination in the development and implementation of a comprehensive federal strategy. The scope of the contract covers securing annual appropriations, federal approvals and assisting in the definition and promotion of the agency's interests with the executive and legislative branches, including during the reauthorization of the federal transportation programs.

The agency's 2012 federal agenda will be significant to help ensure the agency's federal funding assumption of almost \$900 million will be achieved over time.
