Tacoma-to-Lakewood Maintenance of Way Contract

PROPOSED ACTION

Authorizes the chief executive officer to execute a five-year contract with Stacy and Witbeck, Inc., to provide track, signal and bridge maintenance services for the Sounder Tacoma-to-Lakewood line for a total authorized contract amount not to exceed \$8,966,000.

KEY FEATURES

- This contract will provide for the required track, signal and bridge maintenance for Sound Transit's Sounder line from Tacoma-to-Lakewood with an option for maintenance from Lakewood-to-Nisqually. The Lakewood-to-Nisqually option will only be exercised when the WSDOT Point Defiance by-pass project is completed.
- The contract will go into effect once the D-to-M Street construction is completed.
- The Federal Railway Administration (FRA) has progressively higher regulatory standards for track maintenance depending on the speed of the trains operating on the track. Currently the track is maintained for low-speed freight operations only. This scope of this contract will fulfill FRA requirements higher-speed Sounder passenger train operations.
- This contract will provide:
 - o Track, signal and bridge maintenance for the Sound Transit-owned Lakewood Line
 - Signal maintenance on the 1.3 miles of Tacoma Rail on which Sounder operates
 - Required FRA inspections
 - o Graffiti/Vandalism removal within 24 hours
 - Inspection and repairs for unanticipated maintenance needs
 - o Emergency response services as required
 - Ride quality inspections
- The requested amount covers all five years of the contract and the Lakewood-to-Nisqually option.

PROJECT DESCRIPTION

Sound Transit purchased the Tacoma-to-Nisqually railroad line from BNSF in 2003. The line required improvements to the infrastructure in order to accommodate Sounder commuter and Amtrak intercity operations. The D-to-M Street segment of the line is 1.2 miles and currently under construction, with completion scheduled for this summer. The M-to-Lakewood segment of the line is 7.2 miles.

The Tacoma-to-Lakewood line is 8.4 miles long and includes three stations – the Tacoma Dome, South Tacoma, and Lakewood.

This action will be funded from Sounder Maintenance of Way budget.
