PROPOSED ACTION

Authorizes the chief executive officer to execute a two-year contract with a two-year option to extend with Consolidated Press to provide printing services for the Ride the Wave transit guide for a total authorized contract amount not to exceed \$955,501.

KEY FEATURES

- This contract would provide printing and production services for the Ride the Wave transit guide, which provides comprehensive information to riders on all Sound Transit services. The transit guide is published three times a year at each transit service change.
- The scope of work includes printing and binding approximately 125,000 to 130,000 transit guides according to Sound Transit's schedule.
- The amount requested covers the initial two-year contract and the option to extend for an additional two years.

PROJECT DESCRIPTION

The Sound Transit's Ride the Wave transit guide provides information on all Sound Transit services, including maps, time schedules, how-to-ride and accessibility rider information.

FISCAL INFORMATION

The Ride the Wave transit guide budget is included in the Marketing and Rider Information budget for each service mode. The budget table below illustrates the budget impact of this action.

Sound Transit will produce approximately 125,000 to 130,000 copies of the transit guide each service change. Sound Transit used to print 150,000 copies of the transit guide each service change, but has reduced the number of transit guides by providing more online options to customers. New online options include a redesigned website launched in early 2011 and the user-friendly mobile site launched in October 2011. To continue the effort to further reduce the amount

of printed books, additional on-line/application-based schedule information is being researched and planned for development over the next few years.

A request for proposals for printing services was issued that included a cost-saving option to reduce the price per book by 2% for orders of 110,000 books and above. The agency received three proposals and Consolidated Press was selected as the successful proposer.
