Contract Amendment for Civil Engineering/Architectural Final Design Services for the Northgate Link Extension

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Jacobs Associates to provide additional final design services, additional bid support, and design services during construction for the Northgate Link Extension in the amount of \$21,842,165, with a 10% contingency of \$2,184,217 totaling \$24,026,382, for a new total authorized contract amount not to exceed \$85,558,106.

KEY FEATURES OF PROPOSED ACTION

- Under this contract amendment, Jacobs Associates will provide additional final design and bid support services for the Northgate Link Extension.
 - Additional final design services are needed to revise and augment the design in response to changes made through the value engineering process and to address unanticipated design changes and third party requirements.
 - Additional bid support services are needed to prepare and evaluate four contract bid packages that are within the scope, but were not included in the original final design contract. The scope of this work includes finalizing bid documents, responding to bidder questions and evaluating the bids.
- This contract provides funding for Design Services During Construction (DSDC) for all Northgate Link Extension civil design packages. The original final design contract included an option for DSDC, but it was not included in the contract amount.
- This action extends the contract duration for final design to accommodate the current contracting strategy with GC/CM participation in finalizing bid documents for the stations.

PROJECT DESCRIPTION

The Northgate Link Extension is a 4.3-mile extension of light rail from the University of Washington station north under the campus via twin-bored tunnels to the underground U District Station along Brooklyn Avenue NE between NE 43rd and NE 45th Streets, an underground Roosevelt Station along 12th Avenue NE between NE 65th Street and NE 67th Street, and continuing to an elevated station in Northgate along 1st Avenue NE spanning NE 103rd Street. The Northgate Link Extension is scheduled to be completed in September 2021 and will provide an interim terminus for Link at Northgate until the Lynnwood Link Extension is in service, currently anticipated in 2023.

FISCAL INFORMATION

This action is within the adopted baseline budget and sufficient monies remain after approval of this action to fund the remaining work in the Final Design phase as contained in the current cost estimates.

SMALL BUSINESS PARTICIPATION

Jacobs Associates committed to a small business participation goal of 17.43% in their original contract. To date, they have achieved 20.56% small business participation.

For this amendment it is anticipated that the small business participation will be 16.95%, which consists of a participation goal of 20.98% of final design activities and 16.13% of design support during construction activities.

PRIOR BOARD/COMMITTEE ACTIONS

<u>Motion M2010-85</u> - Authorized the chief executive officer to execute a contract with Jacobs Associates to provide civil engineering and architectural final design services for the North Link – UW Station to Northgate project (Northgate Link Extension) for a total authorized amount not to exceed \$61,531,724.

ENVIRONMENTAL COMPLIANCE

Pursuant to the National Environmental Policy Act (NEPA) and the State Environmental Policy Act (SEPA), Sound Transit and the Federal Transit Administration (FTA) issued the North Link Final Supplemental Environmental Impact Statement (SEIS) on April 7, 2006. The Final SEIS is a supplement to the Central Link Final Environmental Impact Statement (EIS) issued in November 1999, and discusses the environmental effects of extending light rail from the Pine Street Stub Tunnel to Northgate in the City of Seattle. In March 2012, FTA and Sound Transit issued a NEPA Re-evaluation and SEPA Addendum addressing design refinements for the North Link project.
