# Sole Source Contract for Disadvantaged Business Enterprise Program Disparity Study

# PROPOSED ACTION

Authorizes the chief executive officer to execute a sole source contract with Browne, Bortz & Coddington, Inc., to conduct a disparity study for the Sound Transit, for a total authorized contract amount not to exceed \$225,000.

# **KEY FEATURES**

- Sound Transit is required to establish and administer a Disadvantaged Business Enterprise (DBE) Program as a Federal Transit Administration (FTA) funding recipient that awards prime contracts in excess of \$250,000.
- A disparity study is necessary to provide Sound Transit with the analysis needed to determine
  the nature of and the extent to which remedial actions are necessary to achieve the purposes
  of the DBE Program in accordance with FTA regulations.
- The study scope of work includes:
  - Reviewing Sound Transit's current DBE goals and methodology
  - Developing a legal framework and producing an analysis of federal requirements and state laws related to a Federal DBE Program
  - Analyzing the use of minority and women-owned firms and the contract amounts those firms would be expected to receive based on their type and size
  - Summarizing disparities between minority/ women-owned firms and firms that are neither minority nor women-owned
  - Producing a final report that includes recommendations for the Agency's DBE Program
- A sole source contract is necessary for this contract because Browne, Bortz & Coddington, Inc., (BBC) owns proprietary data relating to contracting and minority- and women-owned firm availability in the state of Washington.

# **PROJECT DESCRIPTION**

The DBE Program assures that all procurements and contracts are administered without discrimination on the basis of race, color, sex or national origin and that DBE firms have an equal opportunity to compete for and participate in all agreements, contracts and subcontracts awarded by Sound Transit or its contractors. In 2009, Sound Transit submitted a three-year DBE utilization goal of 18.39% to the FTA based on detailed engineer's cost estimates for upcoming construction and construction-related work. Sound Transit has petitioned the FTA for an extension of that goal, pending completion of a comprehensive disparity study that will enable the Agency to establish factually-based, narrowly-tailored, legally defensible utilization goals based upon current data.

The statistical documentation upon which Sound Transit determined its 2009 DBE utilization goal of 18.39% was derived from a state-wide 2005 Washington State Department of Transportation (WSDOT) availability/disparity study conducted by the National Economic Research Associates (NERA) for WSDOT. Sound Transit subsequently engaged NERA to disaggregate those data to establish the statistical basis for Sound Transit's DBE utilization goals. Recent advice letters from the FTA as well as federal case law strongly indicate that both statistical and anecdotal data must be documented to measure the existence and extent of discrimination in the specific marketplace; that DBE utilization goals must be narrowly tailored to the evidence of discrimination in the specific marketplace; and those data must be timely and "current" (generally interpreted to mean no more that 5-6 years old).

A current disparity study is necessary to support the Sound Transit DBE Program. The disparity study from which Sound Transit disaggregated data to support its current DBE Program was conducted more than seven years ago and the "shelf life" for disparity studies is generally considered to be five to six years. Consistent with the United States Department of Transportation regulations and guidelines, Sound Transit will submit to the FTA its goals for DBE utilization based upon the analysis, documentation and recommendations that will be provided by BBC. The anticipated completion date is June 2013.

This action will allow Sound Transit to:

- Obtain a reasonably current and high-quality disparity/availability study to support its DBE Program goals
- Obtain a disparity/availability study that will be tailored to Sound Transit's specific contracting activities
- Determine whether, and to what extent, there is a need for race-conscious (DBE) goals to achieve equitable participation on the part of women and people of color in transit related construction and construction-related contracting opportunities.
- Provide additional credibility to the goal-setting process for DBE and non-DBE firms who contract with Sound Transit
