## PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Questica, Inc., to procure, implement, and provide five year licensing for a budgeting system in the amount of \$834,206, with a 10% contingency of \$83,421, for a total authorized contract amount not to exceed \$917,627.

# **KEY FEATURES**

- Questica, Inc., will provide a new budget development and reporting system for Sound Transit and five years of licensing.
- Sound Transit currently uses multiple tools to develop and report budgets, such as spreadsheets and staff-developed databases that do not interact together seamlessly. The current budget tools require manual reconciliation, consolidation and the use of multiple systems to report Sound Transit budgets.
- The new system will improve budgeting efficiency by automating data collection and standardizing the budget processes. It will allow Sound Transit to centralize budget data to improve data access and analysis, and allow users to quickly create consistent and consolidated reports using a common level of detail.
- The contact amount includes installation of Questica, Inc.'s TeamBudget budgeting system, five years of product licensing, and training for Sound Transit staff.
- After five years, procurements for additional licensing and annual software maintenance are expected to be awarded on a proprietary basis, because the software application is proprietary and available only through Questica, Inc.

The Information Technology Program provides budget for the costs of agency wide computer, software and other information technology capital projects.

A motion of the Operations and Administration Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract with Questica, Inc., to procure, implement, and provide five year licensing for a budgeting system in the amount of \$834,206, with a 10% contingency of \$83,421, for a total authorized contract amount not to exceed \$917,627.

#### BACKGROUND:
