PROPOSED ACTION

Authorizes the chief executive officer to execute a sole source contract with Siemens Corporation to provide propulsion test bench equipment to support Central Link fleet maintenance for a total authorized contract amount not to exceed \$700,000.

KEY FEATURES

- This action procures test bench equipment to test and rebuild the propulsion components of light rail vehicles (LRV) in-house. The requested amount covers equipment procurement, training and instructional manuals.
- The propulsion systems installed on the LRV fleet are manufactured by the Siemens Corporation and therefore, Siemens-manufactured test bench equipment is required to maintain the LRV propulsion system.
- Sound Transit will experience cost savings over time by testing and rebuilding light rail
 vehicle propulsion components in-house instead of sending the components out to the
 Siemens factory for the work.

PROJECT DESCRIPTION

The Central Link system provides service between Westlake Station and Sea-Tac Airport and has been in operation since July 2009. The fleet includes 62 vehicles manufactured by Kinkisharyo with Siemens Corporation propulsion systems.
