PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with KBA, Inc. to provide construction management services for the Sounder Mukilteo Station South Platform and Station Buildings project, in the amount of \$1,500,000 with a 10% contingency of \$150,000, for a total authorized contract amount not to exceed \$1,650,000.

KEY FEATURES

- The Construction Management Consultant (CMC) will provide support to the Sounder project team in managing the Mukilteo Station South Platform and Buildings construction contract.
- The CMC scope of work includes the following construction management and support functions: resident engineering, office engineering, field inspections (civil, structural, architectural, utilities, mechanical and electrical), construction cost estimating, change orders and claims administration, scheduling, construction safety oversight, quality control services including materials testing and surveying, document control services, and other construction management services as required.
- The term of this contract will extend from Notice to Proceed through Final Acceptance of the construction project.

PROJECT DESCRIPTION

The Sounder Mukilteo Station South Platform and Station Buildings project is the second stage of construction for the new commuter rail facility adjacent to the proposed Washington State Ferries dock and the expanded facilities for Community Transit service. This project consists of the construction of the south platform and station buildings including stairways, elevators, utilities, a pedestrian bridge, and other infrastructure.

FISCAL INFORMATION

This action is covered within the current adopted lifetime budget for the project. The Proposed 2013 Budget will include increases to the project lifetime budget and the construction management phase that will cover the phase level budget shortfall created by this action.

The shortfall in the construction management phase budget is due to the need for additional time and efforts necessary to administer this project in a very constrained site. This project is able to move forward as protracted right of way issues have been resolved. With the final design advancing, a revised lifetime baseline budget will be established and included in the 2013 proposed budget.

BACKGROUND

The Mukilteo Station project is part of the Sound Move plan approved by voters in 1996. The project consists of platforms on the north and south side of the railroad tracks with elevators, stairs, and an overhead pedestrian walkway connecting the two platforms. Other amenities include passenger shelters, benches, bicycle lockers, closed circuit television, ticket vending machines, and parking.

The south-side platform will be located on BNSF right-of-way adjacent to the tank farm property currently owned by the United States Air Force (USAF), and east of the Mukilteo Speedway. The South Platform project is being developed in coordination with future WSDOT plans for a new ferry terminal, and redevelopment plans for the tank farm property.

Some of the south platform improvements, including the overhead pedestrian walkway, will be constructed on the tank farm property. The USAF plans to transfer the property to the Port of Everett following completion of environmental documentation in 2012. The Port of Everett has committed, through a letter of intent, to entering into either a sale agreement or a long-term lease with Sound Transit to allow continued use of the south platform improvements after it purchases the tank farm property from the USAF. The USAF has agreed to lease the tank farm property to Sound Transit for 5 years while it pursues transfer of the property to the Port of Everett.

Because of issues that have delayed the transfer of the tank farm property to the Port of Everett, the original Mukilteo Station project was split into two phases in 2007 - the North and South Platform improvements. The North Platform improvements and the station parking lot are complete and have been operating since 2008.

The Mukilteo Station South Platform and Station Buildings construction contract is expected to be advertised for bids in the fourth quarter of 2012 with construction commencing in the first quarter of 2013.

The CMC scope of work includes the following construction management and support functions: resident engineering, office engineering, field inspections (civil, structural, architectural, utilities, mechanical and electrical), construction cost estimating, change orders and claims administration, scheduling, construction safety oversight, quality control services including materials testing and surveying, document control services, and other construction management services as required.

The Mukilteo Station South Platform and Station Buildings construction contract is expected to be advertised for bids in the fourth quarter of 2012 with construction commencing in the first quarter of 2013.
