PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Jet Cleaning and Maintenance to provide pressure washing services at Sound Transit facilities in the amount of \$267,623, for a new total authorized contract amount not to exceed \$466,816.

KEY FEATURES SUMMARY

- The contract covers Union Station and 28 Tacoma Link, Sounder and ST Express facilities.
- The scope of work includes monthly and semi-annual pressure washing services and allows for additional unscheduled maintenance when needed.
- The work is performed on an approved schedule with set rates, and additional work is arranged by task order.
- The amount requested is sufficient to cover the remaining three one-year options.

BACKGROUND

In November 2010 Sound Transit advertised an Invitation to Bid. Jet Cleaning and Maintenance was the lowest responsive bidder. As a result of previous issues with pressure washing contractors, Sound Transit decided to limit the contract period and amount during a trial period.

In January 2011, Sound Transit entered into a one-year contract with Jet Cleaning and Maintenance with four one-year options in the amount of \$78,062. This contract was executed under the CEO's authority. In September 2011, an additional \$78,063 was added to the contract to cover costs associated with added stations and unanticipated work. Based upon the contractor's performance during the first year of the contract, the first of four option years was exercised in January of 2012. In November 2012, another \$43,067 was added to the contract, still within the CEO's authority, to cover expenditures until Board action could be taken.

Jet Cleaning and Maintenance has performed to Sound Transit quality standards. This contract amendment will provide funding to cover the remaining three one-year options available on the contract.

FISCAL IMPACT

Estimated costs for 2013 under the proposed action are within the budgeted amount. Future year spending will be included in the future annual budget requests.

Work at the operational facilities under this proposed action will be funded from the Service Delivery 2013 modal facilities maintenance category included within the Sounder Commuter rail, Tacoma Link light rail and ST Express bus. Funding for work on the Sound Transit administration building, Union Station, comes from Operations Department facilities maintenance budget.

The budget table below shows the 2013 modal facilities maintenance and Operations Department facilities maintenance budget. The pressure wash budget is shown on a separate line as it is embedded in the facilities maintenance budgets. In 2013, the pressure wash budget for Sounder is \$44,000, for ST Express, \$27,000 and for Tacoma Link, is \$9,000. The facilities maintenance budget for Operations Department is \$343,000, and the pressure wash budget for Union Station is \$2,000.
