Task Order Agreement with WSDOT for Construction Services for a Stage 3A Task Order, an Element of East Link Extension (Bellevue Way East-North Ramp)

### PROPOSED ACTION

Authorizes the chief executive officer to execute a task order agreement with the Washington State Department of Transportation (WSDOT) for construction services for Stage 3A the Bellevue Way East-North Ramp, an element of East Link Extension, in the amount of \$10,290,845, with a 10% contingency of \$1,029,085, for a total authorized contract amount not to exceed \$11,319,930.

### **KEY FEATURES SUMMARY**

- The Stage 3A work will be constructed as a Task Order issued under the Umbrella Construction Agreement between WSDOT and Sound Transit.
- This Task Order will provide for the relocation and reconstruction of the I-90 HOV East-North Ramp for Bellevue Way.
- This is an East Link Extension required mitigation that will be delivered as a standalone package to ensure construction is complete in the vicinity of the Bellevue Way Ramps by the third quarter 2015 to avoid conflict with East Link Extension light rail construction.

### **BACKGROUND**

Stage 3A the Bellevue Way East-North ramp work will modify the existing South Bellevue Way/I-90 HOV East-North ramp to eliminate conflicts with the East Link Extension aerial guideway between I-90 and Bellevue Way. The budget to mitigate these conflicts was included in East Link Extension Preliminary Engineering cost estimate. The Sound Transit Board will establish the Stage 3A construction phase budget, as part of the adoption of the proposed 2014 budget.

Stage 3A design work progressed in parallel with the WSDOT administered R8A Stage 3 design until late 2011. At that time the Stage 3A work became a separate design and construction contract package to address constructability issues and to allow the needed East Link related modifications to be accelerated and completed prior to light rail construction.

WSDOT will advertise the Stage 3A project in late December 2013. Construction is anticipated to begin in May 2014 and continue to mid-summer 2015. While most of the work will be out of the traveled way, temporary lane closures at various times affecting the two general purpose lanes to and from I-90 and the two HOV lanes to and from Bellevue Way will be required. The closures will affect only one ramp at a time, and will be planned to minimize traffic congestion as much as possible. WSDOT will continue close coordination with Sound Transit, Bellevue, and Mercer Island throughout construction.

Environmental compliance pursuant to SEPA and NEPA for relocation and construction of the Stage 3A HOV East–North Ramp for Bellevue Way was completed with the East Link Project FEIS

(July 15, 2011) and East Link Extension 2013 SEPA Addendum (March 26, 2013) and associated RODs by FTA (November 16, 2011) and FHWA (November 17, 2011).

### **FISCAL IMPACT**

This action is within proposed 2014 Budget and sufficient funds remain after approval of this action to fund the remaining work in the Construction Phase as contained in the current cost estimates.

The 2013 TIP total represented in the table below includes a Lifetime Budget Amendment of \$4.028M related to the Overlake Transit Center improvements pending Board approval. The current Adopted 2013 Lifetime Budget is \$756.8M.
